
Directions:

May I Transport It?

You may transport up to 15 gallons of liquid, or a dry weight of 125 pounds. If both liquid and non-liquid, the total amount shall not exceed a combined weight of 125 pound. Liquid weighs 8.5 pounds per gallon.

When & Where?

Drop offs can be made Monday -Saturday, 8:00 am - 3:00 pm. See map on back of this brochure.

What's Okay to Bring?

Hazardous wastes are generated by households at your place of residence. Common household hazardous wastes are listed below. Wastes generated from operating a business at at residence do not qualify for the household program.

Paint: Stain, Shellac, Solvents,Thinners, Additives, Oil & Latex Paint.

Adhesives: Putty, Caulk, Epoxy, Mortar, Stucco, Cement, Wood Glue.

Auto: Fuel, Waxes, Motor Oil, Oil

Filters, Batteries, Additives, Antifreeze.

Garden: Sprays, Fertilizers, Ant Traps, Pesticides, Herbicides, Rat Poison,

Gopher Bait.

Miscellaneous: Propane, Spray Cans, Pool Chemicals, Photo Chemicals, Acid Caustic, Wax/Polish, Bleach/Cleaners. The above is a partial list. If you have any questions as to our acceptance policy, please call 415-485-6806

Items That Need

Special Instructions

We accept **Asbestos**, but it needs special packaging. You must call for instructions before you bring these items. Improperly Packaged Asbestos will not be accepted.

What's not Okay to Bring

Explosives, Radioactives, Lab
Chemicals, Medical Wastes (sharps
accepted in approved containers),
Most Compressed Gases.

Who Can Come?

Any Marin County resident, excluding the City of Novato, may transport hazardous waste generated at their place of residence. This includes homeowners, renters, condo/apartment dwellers and trailer park residents. Please bring proof of residency with you (driver's license, tax or utility bill showing your current address).

Who Can't Come?

Businesses, apartment and condominium managers, private organizations, non-profit organizations, for-hire haulers, contractors and painters. These users are considered commercial waste generators and may qualify for the CESQG Program. Contact our Small Quantity Generator Waste Disposal Program at 415-485-5648.

How to Package

All materials must be packaged in sturdy, non-leaking containers no greater than five gallons or 50 pounds in size. If you have a leaking container, place it in a larger non-leaking container (such as a plastic bucket; small containers can be placed individually inside double ziploc bags). Include an original label or a note with as much information as possible about the material (including the brand name and ingredients). **Do** not mix different wastes in the same container. Place the materials up right in your vehicle; brace them so they will not slide or tip over. For safety, we recommend placing the materials in boxes in you vehicle's trunk. Our staff will unload your wastes.
