**SCHOOL DISTRICTS**

**General Qualifications:** Must be 18 years of age or older, a U.S. citizen, a legal resident within the District/School District, a registered voter, and not legally disqualified from holding an office. Cannot be employed by any school district, community college district, or office of education in the County of Santa Clara while serving on a school board.

**SPECIAL DISTRICTS**

**General Qualifications:** Must be 18 years of age or older, a U.S. citizen, a legal resident within the District (s), a registered voter, and not legally disqualified from holding an office.

\* **Additional Qualifications for Lion's Gate Community Services District:** Must be a property owner in the district and must file a form stating property ownership in the district; an example form can be obtained from the Office of the Registrar of Voters.

▪ **Additional Qualifications for Midpeninsula Regional Open Space District:** Candidates are also required to file a Nomination Petition with a minimum of 50 valid signatures of registered voters who live within the Ward in which the candidate is to be voted on.

⌘ **Additional Qualifications for San Martin County Water District:** Must be resident of the district or a property owner in the district. If a landowner, candidate must file a form stating property ownership in the district; an example form can be obtained from the Office of the Registrar of Voters.

♦ **Additional Qualifications for Santa Clara Valley Water District:** Must continue to reside within the electoral district during candidate's term of office, except that no change in boundaries of an electoral district shall affect the term of office of any incumbent director. Candidates are also required to file a Nomination Petition with a minimum of 20 valid signatures of registered voters who live within the sub-district in which the candidate is to be voted on.

† **Additional Qualification Silver Creek Valley Country Club Geologic Hazard Abatement District:** Must be either an owner of land within the District or be designated by an owner of land within the District as their representative.

‡ **Additional Qualification for South Santa Clara Valley Memorial District:** A candidate for the South Santa Clara Valley Memorial District must also be a veteran. Proof of veteran status can be fulfilled by filing a copy of Discharged Certificate Form DD214.

**NOTICE IS FURTHER GIVEN** that all active registered voters will automatically be mailed a Vote-by-Mail ballot package beginning on October 10, 2022; the Vote Centers for said election will be open starting on October 29, 2022, through November 7, 2022, for varying hours of operations. The Vote Centers will be open on Election Day, November 8, 2022, from 7:00 a.m. until 8:00 p.m. All ballots cast in said election will be counted centrally at the County of Santa Clara Registrar of Voters' Office, 1555 Berger Drive, Building 2, San José, California, 95112.
