
We would like to inform you that the housing projects which the National Housing Authority builds are intended for Informal Settlers Families (ISF's) who occupy areas which are considered as "danger zones" or those that are situated near rivers, waterways and railroads. This also includes victims of calamities and communities whose areas will be affected by government infrastructure projects. Lots which are awarded are not offered for free and subject to payment of affordable monthly amortization.

However, you can coordinate with your local government unit for possible housing assistance. If you are a member of the Home Mutual Development Fund or PAG-IBIG, you may visit their office which is located at Westar Bldg. 611 Shaw Blvd., Pasig City or call their hotline number #724-42-44 and inquire about their **foreclosed properties** which you may apply for.

In the meantime, we can include you to our list of applicants so we can assess suitable programs and guidelines which can address the concerns of those who are in need of housing assistance.

We hope that you can coordinate with your local government unit and be able to address your concern in the soonest possible time.
