For the purposes of the REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, EVEHO INGENIERÍA SLP informs you that the personal data of its customers and users of the website SHOOTERSPOOL.NET will be treated in accordance with the principles of transparency, limitation of purpose, data minimization, accuracy, integrity and confidentiality, as well as respecting the rest of obligations and guarantees established in the current regulations.

In order to comply with this regulation and help our customers and users of our services to understand how their personal data is collected, used, processed and protected, EVEHO INGENIERÍA SLP informs you of the following aspects related to your right to the protection of your personal data.

WHO TREATS YOUR DATA?

The entity responsible for handling the personal data of SHOOTERSPOOL.NET customers and users is EVEHO Ingeniería S.L.P., a legal company set up in Spain with CIF: B99386401, registered in the Registry of Commerce of Zaragoza on 5th of September 2013, volume 3996, page Z-55499, folio 175, 1st inscription and registered office at 65 La Jota Avenue, 7th floor, door A, 50014 Zaragoza, Spain.

WHAT ARE THE PERSONAL DATA AND WHAT DATA DO WE TREAT?

Personal data consists of information that identifies or allow to identify individual persons such as the name, the postal address, the email address, etc.

At EVEHO INGENIERÍA SLP, we treat the personal information that the customer provides us for the hiring of a product or service, as well as the information generated through the provision of that service. Based on the principle of minimization, the data that we will be able to deal with will be adequate, pertinent and limited to those necessary in terms of the purposes for which they are treated, and always respecting the customer 's will.

- User Data: it is the data set formed by contact data such as the email, the name and surname, the country of residence and the date of birth, necessary for the hiring and use of our services.
- Data of use of our services: they allow us to know how our users and customers use our products and services in order to improve them.

INFORMATION PROVIDED BY THE USER

The user guarantees that all personal information that may provide is exact and updated in such a way that it truly corresponds to the user's current situation. The user must always keep his data updated and he is the only person responsible for the inaccuracy or falseness of the data provided and for the damage that, for this reason, might cause to EVEHO INGENIERÍA SLP or to others as a consequence of using the services offered by SHOOTERSPOOL.NET.

DATA PROVIDED BY MINORS

Subjects over 16 years old will be able to register themselves as users of SHOOTERSPOOL.NET without their parents' previous consent.

In the case of subjects under 16 years old, their parents' or tutors' consent is required in order to deal with their personal data. If you are under 16 and you have had access to this website without your parents' consent, you must not register yourself as a user.

FOR WHAT DO WE TREAT YOUR DATA?

We treat customer data for the provision of our services, as well as for other purposes that he allows or authorizes with the agreement of the terms of this Privacy Policy or of the specific Conditions of each Product or Service hired.

The data of customers and registered users through the registration forms in SHOOTERSPOOL.NET are collected with the following purposes:

- 1. Provide the service, maintain it and manage the contractual relationship with the customer.
- 2. Tax obligations in compliance with the Directive 2008/8 / CE of the Council, of February 12, 2008.
- 3. Customer service through any of the available ways of contact.
- 4. Statistics, surveys or studies that aim to evaluate the quality of our products and services in order to make business decisions to improve their performance.
- 5. Detect or prevent the abusive or fraudulent use of services.
- 6. Sending information, news and promotions about our products and services.

HOW LONG WILL WE KEEP YOUR DATA?

In order to limit the period of personal data conservation, the data collected will be treated only and exclusively for the time necessary and for the purposes for which they have been collected. They will be maintained to allow the identification of the interested parties for no longer than necessary for the purposes of the processing of personal data.

Specifically, EVEHO INGENIERÍA SLP is subject to compliance with certain legal obligations, such as, for example, the Directive 2008/8 / CE of the Council, of February 12, 2008, regarding the sale of electronic products and services in the European Union, and under which we must store the origin of our customers for at least 10 years from the date of contract.

The personal data of our customers will be kept, at least, during the contractual or commercial relationship between the customer and EVEHO INGENIERÍA SLP.

In addition, we will keep the personal data of our users as long as the deletion is not requested by them and / or as long as we maintain active the provision of our services.

LEGITIMATION

EVEHO INGENIERÍA SLP informs you about the legitimizing bases that will allow the different data treatments:

- Your explicit consent. To subscribe or acquire any of the products we offer in SHOOTERSPOOL.NET, your
 consent and express agreement of this privacy policy is required at the time of your registration. To do this, you
 must check the agreement checkbox about our Privacy Policy, the Conditions of Sale and confirm your email
 address from the email verification we send to you.
- 2. Provision of our services, maintenance and management of the contractual relationship with the customers.

YOUR RIGHTS

- Access: Allows you to obtain confirmation of whether EVEHO INGENIERÍA SLP is processing your personal data, or not, and in such case, the right to obtain information about your treated data.
- Rectification: Right to correct errors and modify inaccurate or incomplete data.
- Suppression: It allows the suppression of the data and that they cease to be treated, unless there is a legal obligation to preserve them and / or other legitimate reasons for their treatment by EVEHO INGENIERÍA SLP do not prevail. For example, when personal data are no longer necessary in relation to the purposes for which they were collected, the customer may request that we delete that data.
- Limitation: It allows you to stop the processing of your personal data in such a way that its treatment is avoided, and we will only keep them for the exercise of claims or legal matters.
- **Opposition:** In certain circumstances and for reasons related to your particular situation, the interested parties may object to the processing of their data. EVEHO INGENIERÍA SLP will stop processing the data, except for compelling legitimate reasons, or the exercise or defense of possible claims.
