My name is Louie Sousa. I live in Turlock, CA, and I have been riding at The Oceano Dunes for over 27 years. Many of the best times with my wife and daughter have been spent at the Oceano dunes. Part the courtship of my wife involved our visits to the Oceano Dunes. Many of the life lessons I taught my daughter were on the Oceano dunes. I have a 10 year old nephew whose parents are not in his life. I have become his father figure, and I have begun teaching him the same lessons I taught my daughter through our visits to the Oceano dunes. The Oceano dunes are much more than a riding area. It is a place where family and friends go to reconnect, enjoy each other's Company, and create bonds and relationships that last a life time. I heard an interesting comment at last February's Coastal Commission meeting. How often in these times do you see teen agers want to be with their parents? I know when, and where, at the Oceano Dunes. If you take these dunes away for off road use, you take all these things away.

I have not seen any information to support the resident's claims. I see information, but it does not make any sense. Wind blows at the beach. The beach has soft sand. The wind will pick up the sand and it will become dusty. It did this before anyone ever rode vehicle on the dunes; it does it now, and will continue to do it until Mother Nature decides to stop it.

As I previously stated, I have been going to Pismo for 27 years. I have been exposed to the environment at the Oceano Dunes. I do not have any respiratory health issues related to the being exposed to the Oceano environment. Neither does my wife, daughter, or nephew. None of the people I know who also go to the Oceano suffer from any respiratory health problems related to their time spent at the Oceano dunes.
