All we are asking is that you look at the big picture and not be one sided in your decision making. Please look at the financial impact on every business within a 20+ mile radius of the dunes. What do you think would happen to all of them if you closed the dunes? How many jobs would be lost? How high would your unemployment rate be? How many businesses would close? How many houses would be foreclosed on? How many apartments would be vacant? Do you have even the slightest idea of how much revenue the dunes generate for your area? Gas, food, lodging, rentals, sightseeing, movies, hardware stores, gift shops, vehicle repairs, etc. The list goes on and on and on. I'll give you one example: while we're there for ten days we spend approximately \$200 on just gas alone, now times that times the 999 other campsites & day campers, that's a lot of money just on gas. Plus we eat out at the local restaurants, shop at the grocery stores, other smaller local stores, outlets, etc. I guarantee the dunes generate a considerable amount more revenue than the hand full of residents that are complaining about the dust ever will. We are there to contribute to the economy in your cities and county and enjoy all that you have to offer. We are not there to do any harm contrary to what some might believe.

As for the blowing sand/dust, I'm sorry but this just makes me giggle. We have been on the beach when there has been almost no one there and the wind still blows the sand.
