

Portland Streetcar was created to accomplish three goals:




Community Growth

The Pandemic Challenge

The COVID-19 pandemic changed the way we live, and travel, beginning in March 2020 and lasting through this year.

We immediately took steps to keep riders and employees safe while continuing to provide the essential transit service on which our community relies.

- Masks required and provided on-board all vehicles
- Additional crews to clean and sanitize vehicle interiors
- Removal of on-board fare machines to limit touchpoints
- Closed ventilation for operator cab

The Federal Transit Administration rewarded these bold steps with a COVID-19 Research Demonstration Grant to fund additional measures yet to come:

- · Transition to easy-to-clean, nonporous vinyl seat covers
- Upgraded screens at stops to provide more comprehensive rider information
- New position of Rider Ambassador to ride the system to help all riders, especially those most vulnerable, get where they need to go safely





Building Our Community

Portland Streetcar continues to be a force for economic development and access to opportunity.

Portland Streetcar has spurred significant investment and housing development within ¼ mile of the streetcar alignment. This past year:








An Extension in Northwest

Planning work continues for a northern extension of the NS Line along NW 23rd Avenue to Montgomery Park in Northwest Portland.
