



## Halton Hills Hydro Summer Prize Pack contest

### Official Contest Rules

#### 1. ELIGIBILITY

(1) An Eligible Contestant is an individual who is:

(i) a Residential consumer (as set out in the Conditions of Service) of Halton Hills Hydro Inc. (the “sponsor”) with an active account at the time of the draw that is in good standing.

(ii) a legal resident of Ontario, Canada;

(iii) An individual at least 18 years of age;

and

(iv) Enrolled in one (1) or more of the Fridge & Freezer Pickup, Heating and Cooling incentive or the peaksaver PLUS™ program during a community event.

(v) All potential winners must provide proof of enrollment/registration in the saveONenergy programs, Fridge & freezer pickup, Heating and Cooling incentive and/or the peaksaver PLUS™.

(2) Employees and Directors of Halton Hills Hydro, Halton Hills Community Energy, Harvester Energy Canada and SouthWestern Energy and their immediate family members and, persons residing with an employee or director or residing with a member of their immediate family members, are not eligible to receive a Prize.

(3) No purchase necessary.

#### 2. HOW TO ENTER

To qualify customers must register in one or more of the saveONenergy Programs (Fridge & freezer pickup, the Heating and Cooling incentive and/or the peaksaver PLUS™ ). Potential winners will be entered into the Contest by Halton Hills Hydro. Potential winners will be entered for each program in which they have enrolled, up to a maximum of three (3) entries for each of their residential accounts. Therefore, one entry for signing up for Fridge & freezer pickup, one entry for the Heating and Cooling incentive and one entry for the peaksaver PLUS™. Acceptance of any Prize constitutes acceptance of these Contest Rules.

### **3. PRIZES**

There will be one (1) prize available to Halton Hills Hydro customers at each community event attended by Halton Hills Hydro up to a maximum of 10 prizes.

Each Summer Prize Pack will contain 2 folding chairs in a bag, 2 pairs of sunglasses, 2 beverage cups, one cooler and one beach ball, valued at \$100 CDN.

### **4. DRAW DATE:**

There will be multiple draws. In the week following each Community event, a draw will be taken for the eligible entrants from that event. The draw will be held at Halton Hills Hydro Office (43 Alice St., Acton).

### **5. WINNER SELECTION**

All potential winners must meet the contest eligibility requirements. Odds of winning are solely dependent upon the number of eligible registrations to the saveONenergy programs. This contest is subject to the laws of Ontario and the federal laws of Canada, as may be applicable.

All potential winners must provide proof of enrollment/registration in the saveONenergy programs, Fridge & freezer pickup, Heating and Cooling incentive and/or the peaksaver PLUS™.

Each potential eligible winner will be required to correctly answer a time-limited skill-testing question and must demonstrate that he/she has complied with the Contest Rules before the prize will be awarded.

The Sponsor is not responsible or liable for entries that are lost, destroyed or deleted. There is also no responsibility or liability for any potential entrant's inability to qualify for enrollment in the saveONenergy programs for contest entry.
