ABOUT THE TOMORROW FUND

The Tomorrow Fund was founded in 1985 by a group of local physicians and parents of children with cancer to ease the traumatic financial and emotional burdens that accompany this dreaded disease. Each year, more than 90% of the children in RI and southeastern Massachusetts who are diagnosed with cancer receive treatment in The Tomorrow Fund Clinic. From hospital parking passes to bone marrow transplant expenses, our programs form a "safety net" for these courageous kids and their families as they face the daily challenges and harsh realities of childhood cancer.

On November 11, Veteran's Day, The Tomorrow Fund Teen Group regulars had the opportunity to experience Newport from the air. The group of 7 teens, and social workers Stephanie Atlas and Rachel Bloch, traveled to Middletown, RI and took to the air (3 at a time) with Bird's

In the winter of 2006, Colby Blanchet and Chris Masse decided to hold a small eggnog drinking contest to raise funds towards an independent film project. The event, which they called "Nogfest", was held in Colby's driveway and was a hit on a very small scale. As the years progressed, Nogfest added live music and friendly competitions. What once started out with 20 people in a driveway grew to over 100 people making it necessary to move the event to a new venue in Slater Park.

Chris, encouraged by his Aunt Chris Black, a longtime volunteer and avid supporter, was curious to learn more about The Tomorrow Fund. In 2009, Nogfest founders visited The Tomorrow Fund. After seeing and hearing more about The Tomorrow Fund's Mission, they were inspired and honored to help such an amazing organization. Nogfest 2009, with about 300 people in attendance, raised \$1,200 with proceeds donated to The Tomorrow Fund.

"We imagine the attendance will at least double again for Nogfest 2010. With that in mind, I hope we'll be able to double our donation amount next year and help out hundreds of sick children and their families," stated Chris Masse, co-founder of Nogfest.

Growing Up and Giving Back



In second grade, Danielle Perez developed a strange rash that was later diagnosed as ITP, Idiopathic Thrombocytopenic Purpura. Danielle was seven years old when she became a patient in The Tomorrow Fund Kid.

She began her weekly routine at the Clinic, having her blood drawn, tested and receiving treatment, not able to understand what was wrong. She met many new people in the Clinic.

"They were always so friendly to me. I felt like I was a normal child, in a place that made me feel happy and loved," says Danielle.

Danielle was treated for ITP three times throughout grade school, each time receiving therapy in The Tomorrow Fund Clinic.

Danielle has since recovered from ITP and is a senior at North Kingstown High School. For her senior paper and project, Danielle decided to give back to The Tomorrow Fund for all the support and help that they provide to families.

Her paper explains the impact that support from family, friends, and other has on the track of survival for cancer patients. In tandem with her paper, Danielle organized a board game, card game and book drive collecting over 300 items from throughout her local community.

"I wish I could have seen the faces on the children when I delivered all the items collected but already knew from past experience how this would brighten their lives," Danielle explained. "I'm so grateful for all that The Tomorrow Fund did for me and I knew I had to do something back."

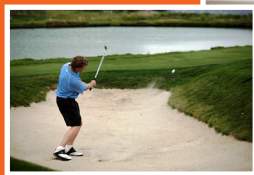

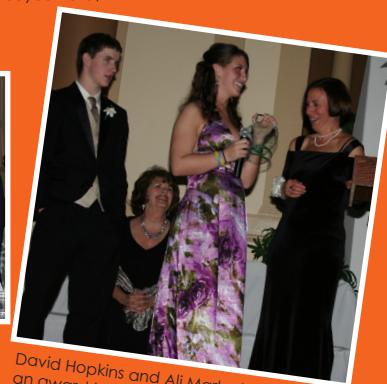

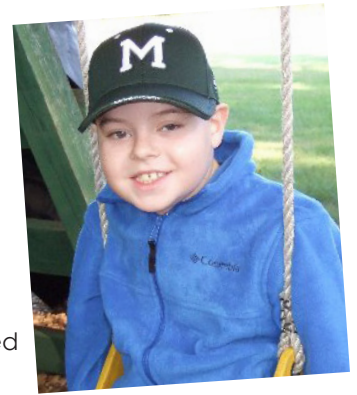

home. I continued to work, though depleted most of my sick and vacation time because I needed to take off so many days.

Family, friends, neighbors...everyone came forth to lend a hand. And in the midst of all the chaos at the hospital there was a presence - a constant guiding light, if you will. It was The Tomorrow Fund staff. What struck me was that Donna, our Parent Consultant had a son who had survived leukemia after a very long haul. That was such a comfort because she knew exactly what we were going through. She helped us sort through our emotions and identify our needs, because when your heart is breaking, it's hard to think clearly. In a word, she was fantastic.



We were offered daily stipends to cover meals, gas and incidentals from The Tomorrow Fund. Because my husband is self-employed and had to stop his contracting work, we needed a little extra help financially. The Tomorrow Fund paid our mortgage twice. They also taught us how to respond to our friends who wanted to help. These wonderful folks took us by the hand and led the way. And they still do!

Tucker is doing wonderfully. He achieved remission on September 22, 2009 and will continue to receive weekly chemotherapy at the Clinic until he is two years cancer free (fall of 2011). Doctors remain very hopeful that he will make a complete recovery.

Believe it or not, he looks forward to going to his chemo treatments, as do we! It's an experience that's hard to describe. We are welcomed like old friends, given anything we need to make our stay more comfortable. We are entertained and informed and above all...cared for.

We tell people that our journey has been filled with many silver linings and the staff in the Clinic and The Tomorrow Fund are our "tour guides" on this journey. So while it's nothing we would wish on anyone, in a way we feel lucky to be a part of it. These are people we will never forget and we hope to be aligned with this organization forever in an attempt to give back all they have given to us.

Jumping for a Personal Cause

Every year people all over the world resolve to do something in the New Year...for the Marcotte family it started with a plunge in the Atlantic Ocean, joining over 1,000 Rhode Islanders at the January 1st Narragansett Pier Plunge. Soon after that day, it became Mike Marcotte's New Year's resolution to raise money and awareness for The Tomorrow Fund by taking the plunge every Sunday after that first day, naming it the "Jump for Tomorrow."

"One day in January, 2009, our daycare called me at work to let me know that our then 5-year old daughter, Alayna, was running a fever. The low-grade fever continued over the next several days. That Friday, we brought her to our family doctor who thought that maybe she had a virus and instructed us to get a urine sample from her. The following day, unable to get the sample, I brought her back in. I just knew something was very wrong. Again, we were told maybe she had roseola but if no rash appeared by the next day, we were to bring her for bloodwork.



The next morning she still just had the fever so my husband brought her to our local hospital for bloodwork. He was only home for minutes before our family doctor was on the phone....Alayna's labwork showed leukemia and we were to go to our local ER. Once we arrived at our local ER, Alayna was immediately transferred to Hasbro Children's Hospital. As soon as we met Dr. Doug Harrison in the Hasbro ER, I knew Alayna was in the right place.



We were admitted and Dr. Harrison confirmed that Alayna had Acute Lymphoblastic Leukemia. She remained in-patient for the first month for intensive chemotherapy, bone marrow biopsies and numerous spinal taps. It was on the second day of this hospitalization that we were introduced to the wonderful people at The Tomorrow Fund. They have supported us in numerous ways and for that we will forever be thankful. We are currently one year into Alayna's two-year chemotherapy protocol and she is doing well. She is not as strong or as fast as her classmates and she misses a lot of school, but she is ALIVE and that is the most important thing.

On August 10, 2009 our pediatrician referred us to Hasbro when our 9 year old son, Tucker, developed an infection from a scraped knee. That summer he had been showing subtle signs of fatigue, paleness and appetite loss, but all of it was so slight that we didn't think anything was truly wrong. He had never been sick in his life aside from an occasional cold.

After examination and several tests, we were called into a small room to meet with the a pediatric hematologist/oncologist who told us that our son had Acute Lymphoblastic Leukemia - a mouthful of words that hit us like a runaway train. The news rocked us to the core, shook our faith and left us feeling alone and terrified.



He was promptly admitted to the 5th floor in Hasbro where he remained for 37 days to undergo the Induction Phase of chemotherapy in hopes that he would achieve remission. How we survived those long weeks I'll never know. It was surreal, like we were going through the motions and looking in from the outside. My husband and I had no choice but to divide and conquer. We took turns at Tucker's bedside and caring for our younger son at
