Clearwell E-Discovery Platform Delivers 90 Percent Reduction in the Cost and Duration of Information Security Investigations

OVERVIEW

A dominant force in the semiconductor manufacturing industry, KLA-Tencor (NASDAQ: KLAC) is mindful of competitive pressure based on the superiority of its technology and caliber of staff. The company regards its intellectual property as a strategic advantage over the competition, and utilizes the most stringent security practices to safeguard its crown jewels.

BUSINESS CHALLENGES

"Email is one of the most susceptible areas of our business because of the everyday reliance on it, and the sensitive material being transmitted externally to partners and across our global workforce every day," Jeff Gurulé, Director of Global Security said. His team is responsible for investigating all potential violations to KLA-Tencor's confidentiality policy, Human Resources code of conduct, and any other issues likely to occur in a large, global company of their size. Once the emails and documents for analysis were collected by IT, Gurulé's team used common search tools and spent hours manually reviewing thousands of emails and other types of electronically stored information (ESI) to find the facts and determine who knew what and when. As with any investigative process, the initial reviews were often followed by additional data requests to IT, resulting in several back-and-forth discussions between the requesting department and IT. The entire process was inefficient for all parties and riddled with cost and potential risk.

"Prior to Clearwell, we used simple search tools that told us a document existed but fell short on identifying whether it was a duplicate, or being able to highlight keywords and provide any context around them," Gurulé said. "Furthermore, they offered no tagging capabilities to mark the documents as relevant or not relevant to the investigation."

Gurulé needed a solution that would present relevant documents in an intuitive and meaningful way for an investigation with robust tagging capabilities that would fit "hand in glove" with their existing process. He also wanted to minimize the strain these searches placed on IT resources, and on his own team of forensics experts who were tasked with reviewing large volumes of messages, taking their time away from higher value projects. Further, the solution was required to comply with the Electronic Communications Privacy Act (ECPA), a privacy guideline KLA-Tencor wholeheartedly supports.

CLEARWELL SOLUTION

In an unprecedented move, KLA-Tencor's IT department approached him after discovering Clearwell and reading about a high-profile energy company who faced a strikingly similar challenge with document analysis.

further analyze the documents into topics. This is done for all collected case documents, but can also be performed across all Exchange servers, PST/NSF files and archives.

Since installing Clearwell, Gurulé has minimized his reliance on IT and experienced a vast improvement in the speed and accuracy of searches. "By eliminating duplicates alone we're able to cull down the total number of documents for review by at least 40 percent, making the analysis process much quicker and less painful," said Gurulé.

In a real-world scenario, Gurulé conducted a series of keyword searches and experienced a 100-percent increase in speed and accuracy.
