A particular request required Petruzzi and a team of 20-30 people to spend more than six weeks and hundreds of hours—sifting through documents in .pst files and searching through data on legacy systems that had been deemed obsolete. Even worse, the painstaking work had to be done after hours to

avoid disruption of the production environment. The entire process proved highly inefficient, extremely costly and understandably frustrating.

By year's end, Constellation Energy had spent a total of 45,000 hours or more sifting through over 700 email boxes, at a significant cost to the company. As the number of requests continued to escalate each quarter and with no other viable solution, Petruzzi had to assign more bodies to the problem and budget more headcount for the coming year.

Document analysis and review continued to be one of the biggest cost-drivers in Petruzzi's department. Subsequently, one of Petruzzi's top priorities for the department was to research and leverage technology to automate the e-discovery process. His team had tried keyword search tools, which did not provide the robust capabilities Petruzzi's team needed to reduce the time and cost of Constellation Energy's investigatory process.
