



Five Year Limited Warranty

Light Emitting Diode (LED) Lamps

Teslights is pleased to provide the following limited warranty covering the Teslights linear LED lamps listed below.

Teslights warrants that the below-referenced lamps comply with their published specifications and are free from defects in materials and workmanship for the respective periods of time set forth below.

If a Teslights LED lamp mentioned below fails due to defects in materials or workmanship within the indicated time period, then Teslights will provide an equal or superior replacement lamp to the direct purchaser ("Purchaser"). This warranty applies only to lamps that have been properly wired and installed and operated in lighting equipment designed and approved for the application and in environmental conditions (temperature, humidity and air movement) within the normal specified operating range of the Lamp.

If a Teslights lamp fails due to defects in materials or workmanship within five (5) years after the date of manufacture, then Teslights will, at its option, either provide a replacement lamp of equal or superior quality if failure is within the first three (3) years, or fix and repair at no charge the existing lamp if after 3 years but prior to five (5) years. This warranty applies only to Teslights lamps that have been properly wired and installed; operated within the electrical values shown on the lamp label; and operated in lighting equipment designed and approved for the application and in environmental conditions (temperature, humidity and air movement) within the normal specified operating range of the system.

Terms & Conditions:

The foregoing lamp warranties apply only to direct purchases from Teslights, but do not apply to failures caused by acts of God or as a result of any abuse, misuse, abnormal use, or use in violation of any applicable standard, code or instructions for use in installations, including, but not limited to, those contained in the National Electrical Code, the Standards for Safety of Underwriters Laboratory, Inc., Standards for the International Electrotechnical Commission (IEC), Standards for the American National Standards Institute or, in Canada, the Canadian Standards Association. Teslights reserves and has the right to examine failed lamps to determine the cause of failure. The date of purchase and lamp installation date must be verified to validate the elapsed operating hours if a warranty claim is made. If lamp life is not properly validated, the lamp date code will be used to establish elapsed burning time based on estimated usage.

The foregoing warranties constitute the sole and exclusive remedy of the purchaser and the sole liability of Teslights for lamp warranties. **NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS MADE OR IS TO BE IMPLIED.** In no event shall Teslights be liable for any other costs or damages including lost profits, indirect, incidental, special or consequential damages.

To Make a Warranty Claim: Retain the failed products and notify your Teslights sales representative within thirty (30) days of the failure. This warranty extends only to Purchaser. However, Teslights will honor, under the terms of this Limited Warranty, valid warranty claims made by Purchaser for the remedy set forth above as a result of warranty claims made to Purchaser by its customers if an authorized reseller.
