



## Foster Agreement

I, \_\_\_\_\_(please print name) hereby volunteer for the True Heart Pinscher Rescue, Inc. (THPR), a non-profit organization established in the State of Kentucky, to keep, protect and maintain Pinschers (and other breeds as needed) in foster care. Upon request, I agree to release the dog(s) to THPR or its representative. I understand that I will be notified of any applications that are received by THPR for the dog(s) I am fostering. If, at this time, I feel I would like to adopt the dog myself, I must inform the THPR Applications Coordinator within 24 hours and begin adoption proceedings. If I do not inform the Coordinator of this, I must allow the dog to be adopted into an approved home.

\_\_\_\_\_ I understand that no reimbursement will be made to me for normal care and feeding of this dog. Veterinary care (initial examination, DHPP and rabies vaccinations, blood test for heartworm or spay/neuter) must be approved in advance by THPR or an authorized THPR representative. True **emergencies** should be taken directly to a Veterinarian and I will contact a THPR Board Member *immediately*. All requests for reimbursement of pre-paid, pre-approved expenses by a non-approved vet must be made to THPR within 30 days and accompanied by written receipts.

*In states and areas where applicable, the dog must be taken to the Rescue's Pre-Approved Vet, where no upfront costs are incurred by you.*

\_\_\_\_\_ I am aware there is no guarantee, warranty or full knowledge of the health and temperament of any dogs fostered by me. I volunteer to accept dogs into my charge as humanitarian acts and agree to release and hold harmless True Heart Pinscher Rescue, Inc., its Officers, Directors and Representatives, from any and all liability or responsibility in connection with the dogs or their foster care.

As a foster home, if involved in an adoption, I agree to forward any signed adoption paperwork in my possession to [trueheartrescue@gmail.com](mailto:trueheartrescue@gmail.com) within 15 days of the adoption/signature date.
