



VOLUNTEER AGREEMENT

I, _____ (please print name) hereby volunteer for the True Heart Pinscher Rescue, Inc. (THPR), a non-profit organization established in the State of Kentucky.

A "volunteer" is anyone who, without compensation or expectation of compensation beyond reimbursement, performs a task at the direction of and on behalf of the rescue. A "volunteer" must be officially accepted and screened by the rescue prior to performance of the task(s) assigned. Unless specifically stated, volunteers shall not be considered as "employees" of the THPR.

Volunteers are responsible for maintaining the confidentiality of all proprietary or privileged information to which they are exposed while serving as a volunteer, whether this information involves another volunteer, adopter, or other person involved in THPR.

The safety of our volunteers is important to us. To that end, we will not release a volunteer's phone number or other personal information to anyone outside of our organization. If your realm of volunteering with THPR finds that you will need to communicate with others outside of THPR, a personal True Heart email address is offered to you for Rescue responsibilities as to not jeopardize your personal email address unwillingly.

Volunteers are expected to keep and maintain the safety of THPR dogs at all times. This includes any decisions made that pertain to THPR dogs during the duration of involvement with THPR.

Volunteers agree to:

- *Perform my Volunteer Role to the best of my ability.*
- *Follow the Organizations Policies and Procedures.*
- *Meet time and task commitments.*
- *Act in a way that is in line with the aims and objectives of THPR and enhances the work of the Organization.*
