PARALEGAL ADVANCED COMPETENCY EXAM

For paralegals who want an alternative to the National Association of Legal Assistant's Certified Legal Assistant examination, now available is the Paralegal Advanced Competency Exam, or PACE.

Sponsored by the National Federation of Paralegal Associations and years in development, the exam was first administered in the Fall of 1996. According to NFPA, the examination is designed to test the competency level of experienced paralegals.

PACE is comprised of two tiers. Tier I addresses general legal issues and ethics. Tier II addresses specialty sections. To sit for Tier I, a paralegal must have either a four year degree (with paralegal studies as part of the curriculum) and two years of experience, or a bachelor's degree (any area of study) and a certificate in paralegal studies. Pursuant to a grandparent provision, during the first three years in which PACE is offered, paralegals not having a four year degree will be able to sit for the examination.

The exam is comprised of true or false questions and is taken on a computer. Testing duration is approximately four hours. Questions are randomly selected from a base of over 1,000. This test format almost assures that no two persons will receive an identical exam and those having to repeat the exam will not be given the same questions.

The cost for taking the exam is approximately \$250. When successfully completed, the applicant receives the designation "Certified Paralegal."

The majority of cases involve divorce. LVL will train paralegals to handle preliminary preparation, leaving the attorney to appear in court. Paralegals also may assist LVL attorneys who do not have regular paralegal services.

LPA PRESENTATIONS APPROVED FOR CLE CREDIT

The National Association of Legal Assistants has approved for CLE credit the following presentations made at 1996 Lafayette Paralegal Association meetings:

Each CLA is required to have 50 hours of CLE credit in a five-year period, or 10 hours per year. A maximum of five credits, or one-half year CLE requirement, could have been obtained by attending LPA meetings.

LOUISIANA PARALEGAL CERTIFICATION EXAM

The LCP examination will be administered April 11 and 12, 1997 in Alexandria and October 3 and 4, 1997 in Baton Rouge. Paralegals who successfully complete the examination will obtain the designation of Louisiana Certified Paralegal, LCP®.

LCP certification is a two-step process. To receive the LCP designation, a paralegal must have obtained a CLA® certification from the National Association of Legal Assistants at the time the LCP exam is taken, or must obtain the CLA certification within three years from the date of notification of having passed the LCP exam.

The LCP examination includes mandatory testing of the following: General Law, Ethics, and Civil Procedure, together with four elective subjects to be chosen from the following: Business Organizations, Contracts, Criminal Law and Procedure, Evidence, Family Law, Property, Torts, Wills/Probate/Successions/Trusts.

Examination fee is \$175 for members of the Louisiana State Paralegal Association members and \$195 for non-members. More information may be obtained by contacting Jessie Cormier, CLA, at (318) 266-1194.
