On July 28<sup>th</sup> a major fire broke out in the forest above Mountain View, Wyoming. Six Hundred (600) firefighters from around the United States known as Team Black were brought in to help combat the fire and keep damage down. Post # 36 went to the command center to offer any assistance they could provide. We got to meet and know some of the firefighters. On August 2<sup>nd</sup> the incident commander from Team Black contacted IPDC, Tom Dean and explained to him that while doing some mop up one of the firefighters found a flag that was almost totally burned up. He picked up the flag off the ground and carefully placed it in a box and brought it to the Mountain View incident command center. He asked Tom if the Post would

properly dispose of this flag. This moved Tom almost to tears at the tender care this firefighter had gone to so he could get this symbol of our country to the proper place for a proper disposal.

As you can see by the picture there was not very much left of this flag. I know so many others may have just left it and never bothered to pick it up let alone to get it to a place for proper disposal. Post # 36 is so humbled that we will be able to perform this service.

# Department Commander's Project, 2016-2017

## Project Healing Waters Fly Fishing, Inc. Program

Project Healing Waters Fly Fishing (PHWFF) began in 2005 serving wounded military service members at Walter Reed Army Medical Center returning from combat in Iraq and Afghanistan. The Project Healing Waters Fly Fishing program provides basic fly fishing, fly casting, fly tying and rod building classes, along with clinics with participants ranging from beginners who have never fished before, to those with prior fly fishing and tying experience who are adapting their skills to their new abilities. All fly fishing and tying equipment is provided to the participants at no cost. Fishing trips, both one day and multi-day, are also provided free of charge to participants.

PHWFF is unique in that our volunteers are teaching classes on an on-going, long term basis. It is much more than a one day fishing trip. For many participants, particularly disabled veterans, the socialization and camaraderie of the classes are just as important as the fishing outings, and provide them a new activity.

The Platte Rivers Program of Project Healing Waters Fly Fishing serves veterans in northeastern Colorado and Southeastern Wyoming. "The Water Holds no Scars" is our slogan. We strive to help veterans experience

solace through fly fishing pristine waters. First and foremost, the Platte Rivers Program of Project Healing Water Fly Fishing is a totally volunteer organization. We take veterans fishing. We practice and teach the art of fly fishing. On some trips and for some reasons we do use other fishing methods. We believe concentration, the demands of fly fishing, and the water itself, offer something miraculous. It's like therapy without the therapist or church without the preacher, or ... just something we can't explain, but we see the transformations again and again. We strongly encourage catch and release. There is no cost to veterans for our fishing trips, fly tying or builds. We do ask vets to pay for the cost of the rod blank if they build a second or third rod.

Please help me in support of this wonderful organization and contribute to the rehabilitation of our veterans while showcasing some of Wyoming's most picturesque locations. Notes from the NEC and Alt NEC

Notes from the National Executive Committeeman (NEC) and the Alternate NEC is our new column in an attempt to keep membership aware of what is happening on a national level. This is in addition to updates discussed in the National Magazine, briefings from officers at Fall Workshop, Midwinter Meeting, District Meetings and the Department Convention, as well as email messages. With all the methods of communication there were still members who stated they were unaware of the dues raise for 2016, even though it had been covered numerous times in other methods.

First we would like to thank membership for their support and electing us to our respective offices. Second we would like to thank those who have gone before us and blazing the way as the Alt NEC/NEC for the Department of Wyoming. Most recent Bob Wright, Jake Jacobs, Tiny Quick and Todd White. They have all helped both of us develop our knowledge of the American Legion, and hone our skills to be able to accomplish the tasks required of the office.

The duties of our office are outlined in the Department of Wyoming By-Laws below:

THE AMERICAN LEGION, DEPARTMENT OF WYOMING, BY-LAWS, ARTICLE I, DUTIES OF OFFICERS, Section 12. NATIONAL EXECUTIVE COMMITTEEMAN. The National Executive Committeeman and the Alternate National Executive Committeeman shall perform such duties as shall from time to time be prescribed by the National Constitution and By-Laws of The American Legion, and such other duties as are usually incident to the office.

The duties as outlined in the National Constitution and By-Laws are located at the following web site: <http://www.legion.org/documents/legion/pdf/constitution-bylaws.pdf> See article VII National Executive Committee of the Constitution of

TAL and Article I, National Executive Committee of the By-Laws of TAL for the duties of the NEC and Alt NEC and the National Executive Committee. Space here does not allow us to print them in their entirety.

The National Executive Committee meets 4 times a year, once less than 24 hours prior to the National Convention and once less than 24 after the National Convention at the convention site. They also meet in less than 45 days after the National Convention, usually in October of each year at Indianapolis at the time of the Commander/Adjutant meeting. The fourth meeting is held each May at Indianapolis. Bob Wright will be the NEC through the National Convention and Terry Miller remains the Alt. NEC to the close of the Convention. At the close of the convention Bob takes off the red Legion cap and puts his Blue one back on, Terry removes the Alt NEC Legion cap and puts on the red NEC Legion cap. At that time Keith Davidson will be authorized to wear the red Alt NEC cap and assume the duties of that office. Keith is a voting member only in the case Terry is not available. The NEC is a member of the Department Executive Committee, with the Alt. NEC filling in when the NEC is not available.

This column is intended to provide information and education on the functions of the office of the NEC and its link between Department of Wyoming and National Office. The NEC is the communications link between the Department of Wyoming and the National Executive Committee of The American Legion (TAL). I.E. dues amount, resolutions, discipline, post operations and closures, etc. The day-to-day communications is accomplished by the Department Adjutant in the Department Office directly to the National Office.

# Korean War Veterans Receive Medals

The Wyoming Veterans Commission, working closely with Wyoming Veterans Service Organizations, coordinated the application and presentation of the Republic of Korea Ambassador for Peace medals in Cheyenne, Casper, and Lander on June 30, 2016. Korean War Veterans or their surviving spouses and family members were presented with the impressive medal and certificate.

Governor Matt Mead and Republic of Korea Consul General Shin Chae-Hyun traveled with Maj. Gen. Luke Reiner, Commander of the Wyoming Military Department, Veterans Commission Chairman Linda Allgeier, Veterans Commission Vice Commander Lee Alley, Governor's Veterans Military Policy Advisor Judge Gary Hartman, and Korean War Veteran Blackie Budd.

The American Legion served in key roles at each of the ceremonies which featured Legionnaires in all aspects of the ceremonies. Notably, Senior Vice Commander Ken Persson served as Emcee in

Lander, the Cheyenne ceremony took place at American Legion Post #6 and featured the Post #6 Honor Guard, and Legionnaires assisted in the Casper ceremonies.

Many of the Veterans were recognized more than 60 years after their service on the ground, in the air, or on the seas around Korea. Proud family members and local dignitaries ensured the ceremonies were well attended and statewide media coverage was prominent.

The Veterans Commission advertised the application process in print and broadcast media, email groups, and social media to help get the word out across Wyoming. More than 275 applications were received with more than 150 awards presented on June 30. Individual award presentations are being scheduled for those who could not attend the June 30 ceremonies.

## Words of wisdom from the Chaplain

We have worked on a number of "For God" articles. Now we will work through a "and Country" article.

There are efforts in education that we can all debate and we equally have great concerns over. Two words explain the evolution of our nation's progressive direction very well, exegesis and eisegesis. Exegesis is the process by which one extracts the truths of literature. Eisegesis pushes understanding into a literary passage. Eisegesis, therefore, impresses a literary rendering with new meaning, extra meaning. One process (exegesis) seeks truth. The other process (eisegesis) attempts to superimpose another meaning on literature.

In today's history we find regular eisegesis. Revisionist history is an example where individuals attempt to glean other truths from *reading between the lines* (so to speak) of historic documents. Exegesis on the other hand attempts to correlate

known facts with a document to better understand it. The following is an example of two different views of our First Amendment to the United States Constitution.

Eisegesis is responsible for giving our government permission to control religious practice through our constitution. This happened because people began including the phrase "*separation of church and state*" which is not in the Constitution. The phrase is taken from a letter Thomas Jefferson wrote to the Danbury Baptists January 1, 1802. This effort coupled with the opening statement of the first amendment, that "Congress shall make no law *respecting an establishment of religion...*" (the establishment clause) has created great misunderstanding. This eisegesis ignores the second part of this phrase, "or prohibiting the free exercise thereof" (the prohibition clause). It has created an

# Honoring the fallen

## Town pays tribute to veterans' sacrifice, service

The atmosphere was somber as members of the American Legion and residents of Pine Bluffs gathered Monday to pay their respects to the men and women who gave the ultimate sacrifice defending America.

Also on hand was United States Air Force Tech Sgt. Erin Callahan.

Callahan was originally on hand in Pine Bluffs to help put out nearly 200 U.S. Flags at the graves of Pine Bluffs veterans. She came back Monday to participate in the ceremonies.

Callahan said Memorial Day is personal to her, citing relatives who have served in the military. She has also lost friends in the line of duty over the years.

"It's emotional," Callahan said.

American Legion member Chuck Radcliffe noted the gravity of the day.

"It means a lot to us," Radcliffe said.

Radcliffe, along with other members of the Legion and volunteers were out Friday placing 190 flags at the Pine Bluffs cemetery to note the people buried there who have served. Radcliffe said there are people who have fought in the American Civil War and the Spanish-American Wars buried there.

All were honored Monday.

### The ceremony

At 9 a.m. sharp, the honor guard was called to attention.

The honor guard consisted of members from Lewis Canady American Legion Post No. 60 and members from American Legion Post No. 6 in Cheyenne. Callahan was also present, holding the U.S. Flag.

About 40 members of the public were on hand to pay their respects as well.

Attendees took a moment to pray for those who gave the ultimate sacrifice and their families. In their prayers they also asked God to send those still serving overseas to safely return home.

Chuck Radcliffe lowered the cemetery flag to half-staff before Mike Heath played "Taps," a somber bugle song played at military funerals to honor fallen heroes.

### The holiday

Memorial Day was established by U.S. Army General John Logan on May 30, 1868 as National Decoration Day, according to [usmemorialday.org](http://usmemorialday.org)

His proclamation reads, "The 30th of May, 1868, is designated for the purpose of strewing with flowers, or otherwise decoration the graves of comrades who died in defense of their country during the late rebellion (Civil War), and whose bodies now lie in almost every city, village and hamlet churchyard in the land."

On the first Decoration Day, General James Garfield spoke at Arlington National cemetery. Five-thousand participants decorated the graves of 20,000 Union and Confederate soldiers buried there.

Today, Memorial Day is celebrated on the last Monday of May. While for many, the holiday marks the unofficial start of summer, it has much more somber implications for those whose loved ones have sacrificed everything so we can enjoy our freedoms here in the U.S.

As Monday's ceremonies concluded, tears were shed. Veterans thanked one-another for their service and their sacrifices. The camaraderie shared by only those who have fought together was readily apparent.

"Now you see what this means to us," Radcliffe said.

### Continuing to serve

Perhaps the biggest takeaway from Monday's ceremonies were the several generations of veterans who turned out.


Veterans young and old paid their respects or participate in the ceremonies.

Callahan, who is serving as a medic out of F.E. Warren Air Force Base in Cheyenne helped set up the cemetery for the ceremonies on Friday. She said several of her comrades in the Air Force were dispatched to cemeteries in the Cheyenne Area to help with ceremonies, but no one was sent to Pine Bluffs, so she volunteered.

Callahan said her grandfather served in the Air Force, reaching the rank of Master Sergeant before passing away. Continuing the legacy she has lost friends in comrades along the way.

As with all service members, Callahan said Memorial Day is an emotional, somber occasion, but participating in the ceremonies in Pine Bluffs was an honor. She said she will be stationed at F.E. Warren AFB for at least the next three years, and she plans to come back to Pine and participate in Memorial Day ceremonies.

"It's a day filled with pride and honor," Callahan said.

imbalance between the two phrases causing "establishment clause" and forced it to overpower the "prohibition clause." First people added the separation clause out of ignorance, a testimony for the questions about our education system. People have added the words to the original document in their personal analysis. This addition in thought and the political influence it represents has caused errors to grow exponentially. Now many assume our country was founded on secular philosophy. Some claim religious freedoms, though not promotable by our government, can be curtailed in public institutions. However, this requires laws and "Congress shall make no law."

Exegesis involves extracting truths from literature in a three-prong effort alien to many today. First, historical – what is the period of time the document was written (time period, political forces, purpose, current events)? Second, context – what is in the sentence, the paragraph, the chapter, the entire book or writing? Third, grammatical – how is the sentence constructed, and specifically how are the words used? This type of literary research is also known as lower criticism. It may involve studying the literature in its original language if foreign (i.e., study the play *Les Misérables* in the original French). Applying exegesis to our Constitution's First Amendment, we find the following.

Historically, the first 10 Amendments of our Constitution were taken from the Bill of Rights. The Bill of Rights was generated in response to

concerns that the original Constitution might eventually permit a tyrannical central government to evolve. Our country broke from Great Britain because of tyranny. The purpose of the Bill of Rights was to specifically curtail governmental authority. For these reasons, the portion which reads, "We hold these truths to be self-evident: that all men are created equal; that they are endowed by their creator with certain unalienable rights; that among these were life, liberty, and the pursuit of happiness..." is counted as one of the most cherished and clearly articulated phrases of freedom and liberty in the world history. Interestingly, while going through the revision process, the only words ever contested were "inherent and inalienable," replaced by "certain inalienable." There was never a question that a Creator bestowed these rights and liberty upon mankind.

Contextually, we begin with the founding document that opens, "We the People..." The people themselves give the individual articles the authority and position they have. Their personal freedom is being exercised as they choose their government, its construct, and the authority it is given. With an understanding of the origination of the amendments themselves, we find the First Amendment stands for a personal freedom to exercise religious belief. This is the first freedom referenced and it is the first restriction on government. We should note that this first liberty is the most personal, the most individual. It deals with how every person is driven, what they live



for, their life’s force and conviction. It is more intimate than any other right. It is thought, spirit, heart. It is a person’s liberty to worship whom we desire in the way in which we desire, to live out our faith personally between us and our god.

Being the first amendment, it sets the tone and authority for what follows. It also flavors the entire document. It does not *call* for government activity, it restricts power. It strips the government of ability. Historically, and contextually our study shows the Constitution denies our government any authority to curtail the freedom for anyone to practice their religion, including inviting others, or simply public fellowship or discussion. This is clearly a “free exercise thereof” for any religion, whether Christian, Islam, Buddhism or Atheism. The amendment itself is labeled “Freedom of Religion, Press,” indicating a preeminence to freedom of religion even above that of the press.

Equally, in reviewing the amendment itself, we find the phrases “Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech,” before the phrase “or the press.” We should also understand that “press” freedoms referred to the printing press, not necessarily people, although they were inherent in it. For instance, you know now it<sup>15</sup> was against the law to print bibles in English until Congress commissioned Robert Aitken.

Grammatically, we find the amendment is a single sentence. Historically, this was how things were written in the 18th century. Many continuing phrases were connected with commas and semicolons to complete a thought. For instance, our Thanksgiving proclamation by George Washington was written in this fashion. The second paragraph of this address is a single sentence, 190 words, connected by 13 comma’s and six semicolons. This form of communication attempts to open with an anchor phrase. In this

fashion the Amendment’s verbiage is focused upon, “Congress shall make no law...” This correlates the history and context with this opening amendment. The next phrases “respecting an establishment of religion, or prohibiting the free exercise thereof;” indicates the amendment deals with a freedom from any law of Congress concerning religion. This is followed by, “or abridging the freedom of speech, or of the press;” again indicating a freedom from any Congressional law that abridges, censors, or edits a person’s speech or freedom of the press. Finally, we find “or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.” This is connected to the first two where people are given freedom to assemble without congressional interference or harassment. Further, a right to petition the government for redress of grievance exists under the same circumstances.

Again, the key phrase of concern then is, “Congress shall make no law...” Those things that follow explain the restrictions inherent in the opening statement. They are individually connected within their phraseology and literarily connected in the whole.
