I understand that only items that meet the high standards of UpCycle Boutique will be accepted for resale. If some of my items are unacceptable for resale, I instruct UpCycle Boutique to either: (Please initial)

_____ Return my items to me, which I agree to pick up at the designated pick up appointment with at least 24 hours notice following the notification that some items are unacceptable. If I fail to pick up my items at the designated pick up appointment time, I agree that such items will become the property of UpCycle Boutique to dispose of as they see fit, including possible donation to a local charity.

_____ I do not wish to have my items returned to me. I forfeit the items to UpCycle Boutique to dispose of at their discretion, including possible donation to local charities.

I further understand that the items accepted for resale become subject to a consignment contract with UpCycle Boutique that begins the day the items are priced and entered into the consignment database. Prices will be set by UpCycle Boutique management at the time of consignment. If accepted items are sold, I will receive 30% of the purchase price for items sold. A 1% processing fee for items purchased by credit card will be deducted from my share of the proceeds.

Any items may be subject to sales, clearance and/or price adjustments according to the market of demand at the sole discretion of management. UpCycle Boutique reserves the right to discount items to facilitate a sale, unless specifically negotiated and agreed in writing.

At the close of a sale that items are contracted to be consigned, unsold items for that sale will be removed from the sales floor. At that time, I instruct UpCycle Boutique to either:

_____ Make my items available to me to pickup at designated pick up times for a period of one week. If my items are not picked up within one week following notification by UpCycle Boutique, I agree that the items will become property of UpCycle Boutique to dispose of as seen fit, including possible donation to local charities.

_____ I do not wish to have my unsold items returned. Such items will be forfeited to UpCycle Boutique to dispose of at their discretion, including possible donation to the local charities.

_____ Automatically transfer my items to the next sale that is appropriate. (Management approval and initials required.)

I understand that my commission (my share of the sales proceeds) will be paid to me by check and will be mailed within 2 week of the close of sale in the self-addressed stamped envelope provided by me. Should I not provide a self-addressed stamped envelope, 60 cents will be deducted from my proceeds to cover the expense.

I understand that UpCycle Boutique will make a concerted effort to sell my items for me, but makes no guarantee that any of my items will sell during the specified sale or at any particular price.

I hereby warrant that I am the owner of the items that I cosign with UpCycle Boutique, and I understand that I will continue to be the owner of such items for the entire consignment period. I agree that UpCycle Boutique, owners, managers or volunteers shall have no liability for the loss or damage of any items I may leave here due to fire, theft, accident or any other cause.
