## **CLEARWATER HMONG ALLIANCE CHURCH OF THE CHRISTIAN & MISSIONARY ALLIANCE, INC.**

### **NTSAB LUG:**

Pawgntseeg **Clearwater Hmong Alliance Church of the Christian & Missionary Alliance, Inc** tau raug tsaa lug lawv le num tswv kev cai huv lub xeev Florida kws ua lawv le kev tswj fwm hab kev ntseeg ntawm cov Ntseeg Yexus hab Kev Koom Teg Qha Txuj Moo Zoo (**The Christian & Missionary Alliance**). Tabsis vim txuj kevcai lijchoj rua tej teg dlejnum has tsi meej rua txhua lub meejom, C&MA txhaj nqua hu kuas txhua pawgntseeg nyag yuav tsum sau nyag le kevcai lijchoj ntxiv hab kaabke ua dlejnum kuas lawv le kevcai lijchoj huv nyag lub xeev. Vim le nuav, Pawgntseeg Clearwater Hmong Alliance Church txhaj le pum zoo tsim tsaab kevcai lijchoj ntxiv nuav lug tuav txuj cai hab kev ua dlejnum kuas yooj yim rua huv pawg ntseeg.

### **Pawgnsteeg Muaj 4 Lub Homphaj Le Nuav:**

1. Tswv Yesus yog tug Tswv Cawm Seej. Kuas cov ntseeg paub meej txug txuj kev dlim txim.
2. Tswv Yexus yog tug ntxuav kuas dlawb huv. Kuas cov ntseeg paub ua lub neej zoo lawv le Vaajlugkub qha.
3. Tswv Yexus yog tug kws khu tau tuab neeg zoo mob. Kuas cov ntseeg muaj chaw casab.

4. Tswv Yexus yog tug kws yuav rov qaab lug ua Vaaj Ntxwv. Kuas cov ntseeg paub moog coj lwm tug lug txais yuav txuj kev dlim txim.

Lub Rooj Saab laaj Txwm Xyoo yog lub 10 hli lub lim tam ib (1)  
ntawm txhua xyoo. Lub Rooj Saab laaj Txwm Xyoo yog kev saab  
laaj ntawm pawgntseeg kws yog xaiv tsaa, kom nyaj txag, kev lui  
hlub hab kev vaam meej ntawm pawgntseeg.

Has txug kev tshaabxu hab cob dlejnum ntawm pawgntseeg, ca  
ncua moog rua lub 1 hlis ntuj lub lim tam ib (1).

## **Phaaj V (5): LUB ROOJ TXWJLAUG HUV PAWG NTSEEG**

### **FEEM 1. COV TXWJLAUG.**

Cov Txwjlaug ntawm lub rooj Txwjlaug yog tug xwbfwb, tug teev ntawv, tug canyaj, tug paab tug canyaj, hab peb (3) tug txwjlaug tuav xaam. Tug thawj ntawm lub Rooj txwjlaug yog tug xwbfwb. Tabsis yog nwg tsi kaam ua, yuav tau siv lawv le kevcai lijchoj rua tej pawg ntseeg Phaaj VI (6) hab Phaaj IX (9).

**FEEM 2.** Lub Rooj Txwjlaug yuav tau xaiv ib tug lug tswj rooj.

### **FEEM 3. KEV SAAB LAAJ.**

Lub Rooj Txwjlaug muaj cai hu kev saab laaj txwm xyoo, txwm hli hab tshwj xeeb. Tug thawj tswjrooj ua tug hu lossis ib nraab ntawm cov txwjlaug pum zoo hab suam npe ces muaj cai hu saab laaj tau.

### **FEEM 4. SUAV TUABNEEG (Credentials).**

Txhua zag lub rooj txwjlaug saab laaj yuavtsum yog muaj cov tuaj koom le 51% txhaj muaj cai saab laaj tau. Zag ob, txawm tuaj tsi txug 50% los saab laaj tau.

## **PHAAJ VIII (8): NOOB NYOOG UA DLEJNUM**

1. Txhua lub meejmom (tshwj tug Xwbfwb) muaj noob nyoog tuav dlejnum yog ob (2) lub xyoos, hab yog pib ua dlejnum thaum lub 1 hlis nub tim 1 moog, hab muaj cai rov qaab lug xaiv dlua tom qaab txhua txhua ob (2) lub xyoos.  
Pawgntseeg tau txais yuav txuj kevciaj lijchoj hloov noob nyoog ua dlejnum nuav rua lub **10/13/2013**.
2. Noob nyoog cov txwjlaug ua dlejnum yog ob (2) xyoos (taam sim nuav huv peb pawgntseeg yog muaj 6 tug txwjlaug, txhua tug txwjlaug yuav tau raug ua dlejnum 2 lub xyoos le maam hloov dlua tshab, ntawm 6 leej ntawd ib xyoos twg yuav tau xaiv 3 leeg, txhais tau has tas muaj 3 leeg taag noob nyoog rua xyoo nuav ces yuav tau xaiv, huas 3 leeg ces lwm xyoo le maam taag noob nyoog).

3. **Article X (10), Section 1.** Cov txwjlaug tuav dlejnum ib leeg ob xyoos, (*txhua xyoo xaiv peb leeg tshab lug ntxiv rua peb leeg qub*).
4. **Article XIV (14), Section 4.** Ib tug txwjlaug tuav dlejnum huv rooj txwjlaug ob xyoos, ib leeg tsuas muaj cai tuav dlejnum huv rooj txwjlaug rau (6) xyoo sib law lag xwb

## **PHAAJ XI (11): PAAB KAAVXWM SAIB KEV XAIVTSAA**

### **FEEM 1. PHAAB KAAVXWM SAIB KEV XAIVTSAA. (ELECTION COMMITTEES)**

1. **Election Committee:** The Election Committee consist the Senior Pastor and 4 members. If the Senior Pastor is absent, Mr. Chairman will act in place of the pastor. If the Senior Pastor is the chairman and is absent, then the Vice Chairman will act in place of the Pastor.
2. The Board of Elders will appoint two members to the Election Committee in July of each year.

3. The Board of Elders will announce to the floor and allow its members two weeks to nominate two or more candidates to the election committee (The deadline for nomination is the first Sunday of August). Mr. Chairman will call for a vote if there are more than two candidates nominated by the floor. The two candidates receiving the most votes will be elected to the Election Committee.
4. If the floor fails to nominate at least two candidates to the Election Committee by the deadline, the Board of Elders will be given authority to appoint one or two qualified person(s) to the Election Committee to complete the committee of four members plus the Senior Pastor.
5. To ensure that the congregation is acting in a professional nomination process, verbal nominations will not be allowed and all nomination forms must be completed, signed, and turned into the Board of Elders by the deadline.
6. A new Election Committee will be elect each year.
7. The Election Committee will be dissolve after each year.

# **HMONG DISTRICT CHURCH FAITH COMMUNITY AND MISSION**

## **I. Key Characteristics of Hmong District Church Faith Community and Mission**

The Clearwater Hmong Alliance Church of the Christian and Missionary Alliance is a community of faith that exists to exercise and express its biblical beliefs both in and through the broader faith community of The Christian and Missionary Alliance (C&MA). These beliefs are grounded in an understanding of Holy Scripture including those beliefs and standards specifically addressed in the *Manual of The Christian and Missionary Alliance (Manual)*.

### **A. The Church Biblical Beliefs.**

This church is a community of faith based on the C&MA's biblical beliefs, which include the following.

1. *Statement of Faith.* This church adopted the statement of faith set forth in the *Manual of the Christian and Missionary Alliance*.
2. *Christian Mission and Values.* This church directs all of its activities in accordance with the following C&MA mission:

We desire to know Jesus Christ as Savior, Sanctifier, Healer, and Coming King and to complete His Great Commission. The Alliance will fulfill His Commission through

Evangelizing and discipling persons throughout the United States,

Incorporating them into Christ-centered, community-focused congregations, and

Mobilizing them for active involvement in a global effort designed to plant Great Commission churches among unengaged, unreached and responsive peoples worldwide.

In carrying out this mission, this church's activities are conducted in accordance with the following biblical values:

Lost people matter to God. He wants them found. Luke 19:10

Prayer is the primary work of the people of God. Philippians 4:6–7

Everything we have belongs to God. We are His stewards. 1 Chronicles 29:14

Knowing and obeying God's Word is fundamental to all true success. Joshua 1:8

Completing the Great Commission will require the mobilization of every fully devoted disciple. Matthew 28:19

Without the empowerment of the Holy Spirit, we can accomplish nothing.  
1 Corinthians 2:4–5

Achieving God's purposes means taking faith-filled risks. This always involves change.  
Hebrews 11:6

## B. Representatives and Other Participants

The representatives of this faith community include all of its pastors, workers, leaders, volunteers, and members who are an integral part of this ecclesiastical body.

## C. Christian Exercise and Expression.

1. *As a Community, this church* believes that the church is the visible organized expression of the Body of Christ and that the church finds broader meaning and outreach in fulfilling its biblical responsibilities within the life and witness of the denomination. In addition, we are committed to follow the biblical command to live out our faith in community and association with other Hmong C&MA believers. Accordingly, this church is itself an exercise and expression of its biblical beliefs and standards.
2. *Through its Mission Based Activities, this church* believes that all of its activities, including the responsibilities of every member of this church should be rendered in service to God as a form of worship. Therefore, this church as a community of faith exercises and expresses its biblical beliefs in every activity, action, and responsibility.

## **II. Christian Community Standards for Ministry Activities**

### **A. General Standards.**

This church shall engage in activities and use its facilities solely to exercise and express the biblical beliefs of the C&MA and to further the mission of both. In furtherance of this mission, this church may provide services or goods to, and may allow use of its facilities by, other groups and persons who are not members or employees of this church, but no activity, nor any use of its building by another group or person, may be conducted or permitted if the governing board of this church determines that such activity or use expresses a message in contrary to the biblical beliefs of the C&MA.

### **B. Specific Concerns.**

For many years the C&MA as a faith community has had concerns with the cultural and legal trends in North America. This resulted in specific statements being adopted by the C&MA over the years to biblically address these cultural concerns. These cultural concerns include but are not limited to marriage, human sexuality, and sanctity of life. This church affirms the biblical beliefs and standards expressed in each of the following statement.

#### *Marriage and Human Sexuality*

As such, this church subscribes to the biblical belief that God creates human beings in His image as two distinct genders, male and female, and that the intended gender identity of an individual is determined by such individual's biological sex at birth. This church applies this belief regarding gender identity in all policies and programs in this

faith community. In addition, this church subscribes to the biblical belief that God has instituted marriage as a covenant relationship between one man and one woman. This church recognizes only such marriages for all policies and programs in this faith community. Further, this church subscribes to the biblical belief that sexual desire is rightfully fulfilled only within marriage and that unmarried singles who abstain from sex can be whole, mature persons, as pleasing to God as persons who are faithful in marriage.

### *Sanctity of Life*

Likewise, this church subscribes to the biblical belief that all life is sacred from conception to death and that individuals are known by God from before the foundation of the world and that human life begins at conception and that death is under the sovereignty of God and not man. This church accordingly believes that no procedures should be performed for the primary objective of terminating a pregnancy and taking the life of an unborn child (such procedures are referred to herein as abortions) except in rarest of circumstances where other biblical, moral principles prevail, such as where it is medically impossible to save the life of both the mother and the child. Similarly, this church believes that no medical procedure should be performed that takes the life of an individual prematurely (such procedures are referred to as euthanasia). This church beliefs further prohibit paying for or otherwise facilitating such procedures.

As dictated by these beliefs, this church as an organization shall not fund abortions in any manner, including through a health care benefit plan that covers prescription drugs that induce abortions, except in the foregoing extraordinary circumstances unless in a particular situation (i) any such drug is prescribed and used solely for a non-abortive therapeutic treatment of a covered medical condition or for an abortion in the foregoing extraordinary circumstances, and (ii) coverage is approved by the plan's governing body or this church's appropriate ecclesiastical authority. In addition, this church shall not participate through its health care benefit plan in a program that uses the plan as a means for providing drugs used to induce abortion, except in the foregoing extraordinary circumstances. Any requirement to facilitate abortions or euthanasia by participating in such a program, and any penalty for failing to participate in such a program, would directly and substantially burden and undermine this church's exercise and expression of its biblical beliefs.

### *Religious Activities*

In conformance with these biblical beliefs and standards, this church engages solely in activities that further its faith mission. All such activities can and should be vehicles for spiritual growth. Therefore, this church considers all of its activities to be a form of religious worship.

This church distinguishes between exclusive religious activities and integrated religious activities. Exclusive religious activities include devotional worship services such as chapel services conducted by this church, and distinctly theological education or pastoral counseling.

Integrated religious activities include activities similar to those conducted by nonreligious organizations for the benefit of society. This church conducts such activities in furtherance of and in accordance with its biblical beliefs.

With respect to restrictions that may be imposed on the use of funds or other benefits offered to this church, this church shall not agree to any restriction that would preclude this church from conducting its integrated religious activities in furtherance of and in accordance with its religious beliefs. This church may agree not to use offered funds or benefits for exclusive religious activities.

### C. Implementation.

To the extent the pastor of this church determines it to be necessary or advisable to further this church's mission or to cultivate this church's faith community, he may establish additional standards based on Holy Scripture and the beliefs and standards addressed in the *Manual* for the activities and programs conducted within the faith community or for this church members or other community participants. The determination as to whether any particular activity or use of this church's facilities is not permitted under this Policy requires spiritual discernment applied to each particular circumstance and shall be made in the sole discretion of the spiritual leaders of this church designated by the appropriate ecclesiastical authority. With respect to uses by other groups or persons, this church may consider without limitation both the content of the proposed activities and whether the group or person is generally perceived by the public as advocating views contrary to the biblical beliefs of the C&MA.

### **III. Community Standards for the representatives of this Church**

#### **A. Roles and Expectations.**

In response to God's calling on their lives, the representatives of this church exercise and express both their own and the C&MA's biblical beliefs and standards by working together to advance the C&MA's faith mission. The representatives of this church are responsible for defining, cultivating, leading, and/or representing the C&MA's faith community as an expression and exercise of their and the C&MA's biblical beliefs and standards.

Accordingly, each representative of this church shall be expected to (i) model these biblical beliefs and standards for others, (ii) perform all of their responsibilities as a service to God, and (iii) comply with the following obligations:

1. *Biblical Beliefs.* Each representative of this church shall affirm their agreement with the C&MA's statement of faith and other biblical beliefs and shall not subscribe to or promote any religious beliefs inconsistent with these beliefs.
2. *Christian Conduct Standards.* The representatives of this church shall at all times (both during working and nonworking hours) endeavor to conduct themselves in a manner that affirms biblical standards of conduct in accordance with theirs and the C&MA's biblical beliefs.
3. *Distinctly Christian Activities.* Each representative of this church shall be ready, willing and able to lead or contribute to distinctly Christian activities such as worship or prayer services.

**B. Noncompliance by Representatives.**

If any representative of this church does not comply with the obligations set forth above, such representative shall have an obligation to disclose such noncompliance to the governing board. The governing Board may determine whether such representative intends or is likely to continue in such noncompliance. If so, then the governing board may dismiss such representative from his or her position on the basis that such representative's noncompliance is inconsistent with and undermines the expression and exercise of this faith community. Such action may be taken in accordance with any applicable procedures in the Uniform Policy on Discipline, Restoration, and Appeal.

**C. Volunteers and Contract Workers.**

Volunteers who are not members of this church are not considered to be representatives of this faith community unless they are serving with the permission of this governing board. Nevertheless, when volunteers and certain contract workers serve with this church, they shall be required to acknowledge that they understand and agree to support the C&MA's mission and values. This church may give preference for such service to volunteers and contract workers who share its biblical beliefs.
