

**Code of Conduct:**

All participants shall treat fellow players, referees, teams, spectators, neighborhood, and the community in a positive, sportsmanlike, and respectful manner.

No player shall strike, shove, or use any unnecessarily rough tactics towards a player, referee, or spectator.

No player shall engage in objectionable demonstration of dissent, unsportsmanlike conduct, taunting or other disrespectful behavior.

No player shall question or dispute the decision of a referee unless acting in a respectful manner as the Captain of the team in question.

No player shall play in a condition that would be a danger to him or herself.

Enforcement of the Code of Conduct will be handled by the referees at each field.

**Waiver and Release of Liability**

I understand participating in flag football is a potentially dangerous or hazardous activity that includes risks, including, but not limited to, the possibility of physical harm or injury, permanent disability, death and damage to property. I hereby expressly and specifically assume all risks, including, but not limited to, the risk of physical harm or injury, permanent disability, death and damage to property, associated with my participation in this activity, including, but not limited to, falls, contact with other participants, weather conditions including rain, ice, snow and cold temperatures, the conditions of the field and event locations, etc., all such risks being known and understood by me. I understand that, except as otherwise agreed to by the R.A.C. Memorial Scholarship Fund in writing, the R.A.C. Memorial Scholarship Fund does not carry or maintain health, medical or disability insurance coverage for any participants in R.A.C. Memorial Scholarship Fund Activities.

Having read this Waiver and Release of Liability ("WRL"), knowing, understanding and willing to assume the risks associated with my participation in this event, and in consideration of being permitted to participate in this event, I, for my heirs, executors, administrators, legal representatives, assigns and any other person entitled to act on my behalf, as well as myself, hereby waive, release, forever discharge, hold harmless and covenant not to sue the R.A.C. Memorial Scholarship Fund, its successors and assigns, its Board Members, its sponsors, event's land owner, other participants and any other representative of the R.A.C.
