**Greetings,**

**Forage Seeding**

Crop insurance coverage ends on **5/21** for forage seeding planted in the Spring of 2024. Please be sure to check your fields for poor stand on last year's Spring forage seeding and contact your agent before **5/21** if you have a possible claim. **Do not destroy or interseed until you talk with your adjustor.**

If you insure forage seeding, this covers both Spring and Fall seeding. If you want to make changes to your coverage or add forage seeding on to your policy this needs to be done by **7/31**.

See below for the final plant date for Spring Forage seeding, acres planted after are not insurable. When forage seeding is planted with a nurse crop (such as oats), the nurse crop must be planted at 50% or less of the normal rate. If you harvest forage seeding after **8/31**, your forage seeding insurance will end at that time, therefore there will be no winter coverage, and premiums will be due in full. New seeding planted after **7/1** is insured as Fall forage seeding.

**Final Plant Dates:** See chart.

*\*\*Dates vary by county- if you have any questions, please contact your agent\*\**

Crops planted after the Final Plant Date will have a reduced guarantee of 1% per day up to 25 days on acres planted after the Final Plant Date. After 25 days following the Final Plant Date, you can elect to "not insure" the late planted acres. Crops planted prior to Early Plant Date will not qualify for replant on those acres.

**Enterprise Units: Must have been elected by 3/15.**

You must qualify for Enterprise Units by meeting the 20/20 rule, per insured crop. 20 acres or 20%, whichever is less, will need to be planted in at least 2 sections.

Example- If you have a total of 75 acres of planted corn, 15 of those 75 acres must be in another section.

**Please contact your agent if you have questions about meeting Enterprise Units.**

**Acreage Reporting**

All crops listed on the policy must be reported at Acreage Reporting.

The deadline for completing insurance acreage reports is **July 15**. Please contact your agent once you have finished planting. Please be sure to keep a copy of your completed FSA maps for your crop insurance agent.

**Precision**

Precision will take your as planted acres from your GPS module and dates to use for your Acreage Report. If you are interested in doing Precision planting or have more questions on this, please let your agent know ASAP.

**Prevent Plant**

Your crop insurance policy comes with Prevent Plant, which covers acres that you were not able to get planted by the Final Plant Date. Please call your agent to submit a claim as soon as you decide acres will be Prevent Plant, do not wait until acreage reporting to let us know that you have Prevent Plant. To qualify for Prevent Plant you must reach 20 acres or 20%, whichever is less, in that unit of unplanted acres. The acres also must have been planted, insured, and harvested in at least 1 of the last 4 years. Max acres paid, is the highest acres planted of your past 4-year history/ crop. Prevent plant acres may affect your eligibility for Enterprise Units. If you question if you will meet EU please contact your agent!

**Replant/Interseeding (not applicable on CAT policies)**

Your crop insurance policy provides coverage for qualified acres that you decide to replant, you must discuss replanting options with your adjustor before you replant or interseed. You must meet the 20/20 rule of the crop you are replanting. Please contact your agent if you have a replant claim. Please see the Replant Claim chart below.

**Dairy Revenue Protection (DRP)**

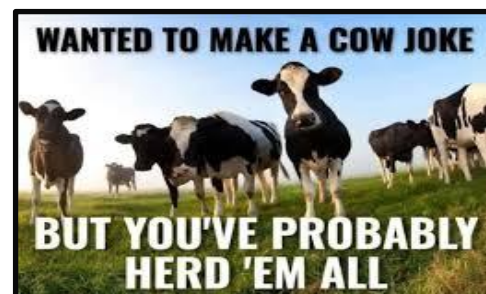
Protects the floor price from decline in markets quarterly. Based off the average CME prices for each quarter. **\*\*Deadline to put in a contract for 3<sup>d</sup> quarter (July- Sept 2025) milk is on/or before June 15<sup>th</sup>\*\***

**Livestock Risk Protection (LRP)**

Protects the decline in future cattle market value for feeder/fed cattle.

**Livestock Gross Margin (LGM)**

Provides protection against the loss of gross margin between commodity price and feed cost
