Whether using tillage or burndown herbicides, starting clean is essential to set the stage for season-long success. Spring burndown products, such as Elevore[®] herbicide, can be a great addition to your herbicide program. Plant-back restrictions may apply.

Foundation residuals should be applied pre-plant or pre-emergence. These herbicides provide reliable support for clean fields all season long. For all products, add appropriate burndown products, tank-mix partners, and adjuvants.

Keep your fields clean by making a post application within 21-28 days after your foundation herbicide application. Always include a residual herbicide to extend control deeper into the growing season.
