
#### **Management Insights**

- Slightly below average ear height and above average root strength should help in-season standability.
- Very good Northern Corn Leaf Blight resistance good shagreen and above average test weight.
- Average resistance to tar spot and Gray Leaf spot and slightly below average mid-season brittle snap tolerance.
