Instructions:

1. The Nomination can be made only by individuals holding beneficiary owner accounts on their own behalf singly or jointly. Non-individual including society, Trust, body corporate and partnership Firm, Karta of Hindu Undivided Family, Holder of power of attorney cannot nominate. If the account is held jointly, all joint holders will have to sign the nomination form.
2. A minor can be nominated. In that event, the details of the guardian of the minor nominee shall be provided by the beneficial owner.
3. The nominee(s) shall not be a trust, Society, Body Corporate, Partnership Firm, and Karta of Hindu Undivided Family or a power of attorney holder. A non-resident Indian can be a nominee, subject to the exchange controls in force from time to time.
4. Nomination in respect of the beneficiary owner account stands rescinded upon closure/cancellation of the beneficiary owner account and the depository shall not be under any obligation to transfer the securities in favor of the nominee(s). Similarly, the nomination in respect of the securities shall stand terminated upon transfer of securities. In case of submission of fresh nomination by beneficiary owner the original nomination already registered if any, in said account shall stand cancelled and the nominee as per the fresh nomination request shall be registered.
5. Transfer of securities in favor of a Nominee(s) shall be valid discharge by the depository and the participant against the legal heir.
6. The Cancellation of nomination can be made by individual only holding beneficiary owner accounts on their own behalf singly or jointly by the same persons who made the original nomination.
7. Nomination can be made up to three nominees in a Demat account. In case multiple nominees, the client must specify the percentage of share for each nominee that shall total up to hundred percent. In the event of the beneficiary owner not indicating any percentage of allocation/share for each of the nominees, the default option shall be to settle the claims equally among all the nominees. Any odd lot after division shall be transferred to the first nominee mentioned in the form.
8. On request of substitution of existing nominees by the beneficial owner, the earlier nomination shall stand rescinded, Hence, details of nominees as mentioned in the FORM 10 at the time of substitution will be considered. Therefore, please mention the complete details of all nominees.
9. Copy of any proof of identity must be accompanied by original for verification or duly attested by any entity authorized for attesting the document, as provided in nomination form.
10. This nomination shall supersede any prior nomination made by me/us and also any testamentary document executed by me/us.
11. This nominee shall supersede any prior nomination made by the account holder(s), if any.
