The Company will promptly respond to the show cause notice and inform the stock exchanges of any material developments in this regard.

Nature and details of the action(s) taken or order(s) passed	SEBI has issued a Show Cause Notice (SCN) to the Company, seeking a response as to why the certificate of registration as a Research Analyst should not be cancelled under Regulation 30A of the SEBI (Intermediaries) Regulations, 2008, read with Section 12(3) of the SEBI Act, 1992.
3.	Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority	The Show Cause Notice (SCN) was received on September 10, 2025 <i>via</i> email.
4.	Details of the violation(s) / contravention(s) committed or alleged to be committed	Pursuant to Clause 3 of the Second Schedule of SEBI (Research Analyst) Regulations, 2014, a research analyst who has been granted a certificate of registration shall pay the prescribed fees every five years from the date of grant of the certificate, within 3 months before the expiry of the period for which the fees have been paid, in order to keep the registration in force. In this regard, the Company has failed to pay the fees that became due in terms of the above provisions. As a result, the Company ceased to satisfy the conditions of registration stipulated under Regulation 13(i) read with Clause 3 of the Second Schedule of SEBI (Research Analyst) Regulations, 2014. Considering the same, SEBI has stated that the Certificate of Registration, which has already expired due to non-payment of fees, may be cancelled and has issued a Show Cause Notice to the Company, calling upon it to show cause as to why the Certificate of Registration should not be cancelled.
