

## **Important Caution Notice for customers and public at large:** Beware of Fraud, Impersonation and fake 5Paisa Apps, websites and platforms

This caution notice is in compliance with the NSE Circular Ref. no. NSE/INSP/61754 dated 25.04.2024 and is addressed on behalf of 5paisa Capital Limited (hereinafter referred to as "5paisa") in the interest of our customers and users of our services.

You are hereby cautioned about unauthorized, unknown and unscrupulous individuals / agencies running the fake whatsapp groups with names "5Paisa Y4 Value Investment Portfolio", "5paisa 172 value investment", F54 5Paisa Official stock Community", "5paisa J03 Value Investment Portfolio" and Mobile application "5Paisa Max", "F54 5Paisa Official" and the unrelated, illegitimate and fake websites such as FIVEPAISASES - https://www.five-paisaaxa.com, FIVEPAISAADV - https://5paisaadv.com/ , https://app.five-paise.cc, "https://play.five-paisa.cc/2393798750/index.html#/" and "www.ramansinghania.net"

These unauthorized individuals / agencies / whatsapp groups and websites have been observed trying to mislead the public at large through whatsapp groups/links/websites and various other social media platforms, websites or mobile applications, etc. ("platforms") by impersonating (pretending) to be associated with 5Paisa as representatives / Authorized Persons / Affiliated Partners / of 5paisa by making unauthorised use of name, logo, trademarks of 5Paisa Capital Ltd. with an intention to cheat and defraud the investors.

It is further brought to your notice that, such unknown individuals / groups may offer fake and misleading financial and other investment products / services/ schemes / trading/ demat/ investment account services through the aforesaid platforms claiming that the same are endorsed or approved by 5Paisa and / or by offering unreasonably high return on investment with a malafide and dishonest intention to mislead and defraud innocent and unwary members of the public, investors and the customers of 5Paisa Capital Ltd.

Please take a note that neither 5paisa Paisa Capital Ltd. nor any other group company, has anything to do with these fraudsters. We advise all our customers and users to be aware of such practices and be more diligent and cautious if you are approached by any such unauthorised individuals or groups.
