

## GRAND PRIZE OFFICIAL RULES

### I. SPONSOR

### II. ELIGIBILITY

Registered attendees must be present to win the April 25th drawing (**See Section VI**) at the Fort Worth Convention Center, located at 1201 Houston St, Fort Worth, TX 76102.
3. The Grand Prize winner must be 21 years of age or older and an authorized representative/Owner of the company to accept the Grand Prize. A copy of the winner's valid identification along with business documentation will be required to redeem the prize. Funds will be made out to the winning company.
4. #### **V. ENTRY METHODS**

10. Tri-State Enterprises will offer digital entries during the promotion period. All entries will be applied to a random drawing using a third-party program known as the "Randomizer." The Randomizer is operated by an independent third-party company.
11. The odds of winning depend on the total number of eligible entries received.

#### **VI. PRIZE DRAWING**

12. Two (2) Grand Prizes will be awarded:
13. \$35,000 USD cash for the Accessory Division. Three (3) finalists will be selected for the opportunity to participate in the award presentation on the main stage on April 25th, 2026, during the Big Money Show. Winner must be present to win.  
Eligible categories include:

  - c) Car Audio/12v

15. The Grand Prizes are non-transferable, and no substitution or alternative prizes will be offered.
