

2022 Sacred Anatomy Energy Medicine Practitioner Training Agreements

The contract applies to both the Practitioner Training and to your Practitioner Certification agreement. All these agreements are necessary to receive the training and certification.

Participation in the Training

- I understand this training is not for people who are emotionally or mentally unstable or who are suffering from an acute phase of an illness. I have been forthcoming with all relevant mental or physical health information that I have submitted. I will inform the instructor of any significant change in my health and capacity during the course of the training.
- During my training it is my responsibility to notify Desda Zuckerman of any changes regarding my application and my physical and mental health and well-being.
- I commit to conduct myself in a professional and responsible manner during the training. I take full
 responsibility for my behavior with and in relationship to teaching staff and other participants. I
 understand my actions affect everyone else and that I, as a member of this class contribute to the
 energy of the teaching space and the feeling in the room as we strive together to create a sacred
 learning environment. I accept this opportunity to "up the level" of my awareness and to step into
 my new role as a SAEM Practitioner.
- I understand Desda Zuckerman is a spiritual practitioner with a ministerial degree and that neither she, nor her teaching associates or assistants are psychotherapists or traditional medical professionals.
- Course completion alone does not guarantee certification. I must attend all classes and pass both an oral review and written Practitioner Exam to successfully be granted certification.
- This training certifies the participant to be a Practitioner, not a teacher of SAEM.
- I will abide by the payment arrangements I have made prior to the start of class

On-Going Education

• Ongoing Education is encouraged, but is not required to maintain your certification. This work is constantly growing, and staying up to date will enhance both your abilities as a practitioner, as well as the SA Field (energetic container) within which we all operate.



• I understand that advancement in SAEM training continues in future Practitioner classes and that Level I & II SAEM Practitioner Training is the first in the series of Practitioner Trainings that will, as a certified Practitioner, be eligible to apply to attend.

Certified Use of SAEM Materials by Certified Practitioners

- Upon being certified as a SAEM Level II Practitioner, you are authorized to use the procedures and techniques taught in SAE Medicine Bag and Energetic Hygiene and Level I & II Practitioner Training in a professional capacity.
- You may use the designation: Sacred Anatomy Energy Medicine Practitioner in professional work and the trademarked name and logo of Sacred Anatomy Energy Medicine to refer to the subtle healing modality created by Desda Zuckerman.
- As a representative of Sacred Anatomy Energy Medicine, I agree to uphold the highest standards of ethical behavior and to make no claim or assertion that Sacred Anatomy Energy Medicine replaces medical care or treatment or that it cures or heals any physical, emotional or psychological disease.
- SAEM Practitioners are welcome to use copyrighted "materials for client education" and are urged to offer them to clients or any other interested party. Copyrighted course materials (workbooks, procedures, videos, other training documents) are <u>not</u> approved for copying and/or distribution to students or clients.
- All new SAEM Practitioners are invited to post their picture, bio and contact information in the Practitioners section of the YSA website. This posting is offered at no charge for two years following certification to support your practice and development as a Practitioner.
- Upon request, Certified SAEM Practitioners may use copyrighted anatomical images for promotional materials.

Restrictions During Training

 I understand during the period of my training as a SAEM Practitioner I will ONLY seek subtle energy healing work from Certified Medicine Bag Carriers, SAEM Practitioners or fellow student trainees in my class. I understand getting other types of energy work during training, while beneficial at other times in my life, may breach the sacred container and impede the development of my relationship with Sacred Anatomy Energy Medicine. This includes but is not limited to: shamanic healing sessions, Reiki, work developed by Barbara Brennan, Donna Eden, Cyndi Dale or Berkeley Psychic Institute as well as any other subtle healing modality. Acupuncture, Cranial Sacral, bodywork and other modalities you are using regularly in your life as self-care are acceptable. Please check with the instructor for clarity if necessary.



- I agree to abstain from taking any psychedelic drugs, mind altering, or consciousness expanding substances including plant spirit medicine during the course of my training with the exception of flower essences. This includes recreational pot smoking but does not include the use of medical marijuana for prescribed pain management which has been disclosed to the instructor
- I agree to abstain from participating in occult activities (for example: séances, table tipping, ghost busting, fortune telling, spell casting and channeling) during the course of my training to be an SAEM Practitioner. I understand occult activities and studies will affect my ability to be trained as a SAEM Practitioner.
- I understand that during my SAEM Practitioner Training I will not be enrolled in any other professional training / certification program or in any spiritual or shamanic training as this will cause conflict for me, for the SA Field, and can cause unforeseen difficulties for the group.
