

# FORTI-MIN + ZINC OXIDE TS-99

## Product Specification Sheet

Forti-Min + ZINC OXIDE TS-99 is a low dust, flow-able mineral supplement formulated to help address calcium, magnesium, sodium and zinc requirements through summer into autumn.

**PRODUCT INGREDIENTS:** Limeflour 66.5%, magnesium oxide 5.5%, salt 12%, zinc oxide 6% and molasses 10%.

### FEEDING RECOMMENDATION

Add Forti-Min Zinc Oxide TS-99 to the diet through the feed at a rate of 200g per cow per day. Please refer the the chart above for recommended addition rates per ton of feed per cow per day. Do not feed less than the minimum rate unless the herd is meeting its zinc requirements from other sources e.g. ZinMol.

### NOTE

The above recommendation is based on a 450kg lactating dairy cow. Using the above guidelines, each cow will be offered 50g elemental calcium, 5.5g elemental magnesium, 8.5g elemental sodium and 9.6g elemental zinc.

### IMPORTANT NOTES

Do not allow access to other zinc products unless the combined zinc intake is recommended for facial eczema prevention. Do not exceed the maximum rate as overdosing may result in zinc toxicity. Zinc requirements will be relative to iron and copper intake.

The feeding of magnesium supplements to dairy cows may increase their risk of clinical salmonellosis. It is recommended that veterinary advice is obtained to ascertain potential risks associated with the use of this product in your environment before product is used.
