

INTERNATIONAL STUDENT PRE-DEPARTURE **FAQS**





LATEST INFORMATION AS AT 7TH DECEMBER 2021

	QUESTION	ANSWER
1.	When will international students be able to enter Australia?	Australia's borders will reopen from 15 December 2021 to fully vaccinated eligible visa holders without needing to apply for a travel exemption. These eligible visa holders include but are not limited to subclass 500 – student visa and subclass 485 - temporary graduate visa.
2.	Who is eligible to enter Australia?	<ul style="list-style-type: none"> • Fully vaccinated (2 doses) with a vaccine approved and recognized by Australia's TGA (Therapeutic Goods Administration) OR mixed doses of any vaccines mentioned above • Proof of your vaccination status • Hold a valid visa • A negative COVID-19 PCR (Polymerase Chain Reaction) test taken within 3 days of departure unless a medical exemption applies • Complete an Australia Travel Declaration (ATD) at least 72 hours before departure <p>Please note that Travel restrictions are now in place for people who have been in South Africa, Lesotho, Eswatini, Namibia, Botswana, Zimbabwe, Mozambique, or Malawi in the last 14 days. Any travellers who have been in these countries in the last 14 days EXCEPT Australian citizens, permanent residents or their immediate family members are not permitted to enter Australia.</p>
3.	What vaccines are recognised by TGA?	<p>As at 2 December 2021, the Therapeutic Goods Administration (TGA) has recognised the following COVID-19 vaccines for the purposes of inbound travel to Australia:</p> <ul style="list-style-type: none"> • Vaxzevria (AstraZeneca) • Comirnaty (Pfizer) • Spikevax (Moderna) • Takeda (Moderna) • Janssen-Cilag (Johnson & Johnson) • Coronavac (Sinovac) • Covishield (AstraZeneca/Serum Institute of India) • Covaxin (Bharat Biotech) • BBIBP-CorV (Sinopharm) <p>Individuals vaccinated with mixed doses will be considered fully vaccinated if all vaccines received are approved or recognised by the TGA.</p> <p>The TGA is continuing to evaluate other COVID-19 vaccines that may be recognised for the purposes of inbound travel to Australia.</p> <p>Up to date information on vaccines recognised in Australia is available on the SmartTraveller website at: www.smarttraveller.gov.au/COVID-19/COVID-19-vaccinations</p>

4.	What should the vaccination certificates be like? (Formats)	<ul style="list-style-type: none"> • Issued by a national or state/provincial-level authority or an accredited vaccination provider • Written In English or another language but with a certified translation • Containing at a minimum: • The same name as in your passport <ul style="list-style-type: none"> i. EITHER date of birth OR passport number ii. The vaccine brand name iii. The date of EACH dose OR the date on which a full course of immunisation was completed <p>Information on foreign vaccination certificates is available on the Australian Passport Office website at: https://www.passports.gov.au/guidance-foreign-vaccination-certificates</p>
5.	Do I have to quarantine? How long should I quarantine?	<p>Travellers returning to Australia may only enter and travel between NSW, VIC and the ACT without quarantining. If you wish to travel on to another state or territory you may not be allowed to enter or may be subject to a quarantine period.</p> <p>Across Australia, states and territories have their own quarantine rules in place. Some require approval to travel across the border from NSW, or even a second isolation period when you arrive.</p> <p>NSW (Blacktown campus)</p> <ul style="list-style-type: none"> • International travellers must go straight to your house or accommodation and isolate for 72 hours (3 days). • Get a COVID-19 PCR test within 24 hours of arrival and do not leave your house or accommodation until you receive a negative result which usually comes within 24 hours but please allow up to 72 hours. • During this period, do not go outside or visit shops, or heavy penalties apply. • Get another COVID-19 PCR test on day 6 and Don't visit high risk places until you get a negative day 6 test result. <p>For more details please visit: https://www.nsw.gov.au/covid-19/travel-restrictions/international-travel-rules</p> <p>TAS (Hobart campus)</p> <ul style="list-style-type: none"> • Travellers who have been overseas (other than low-risk areas in New Zealand, or approved Australian Antarctic Division travellers) or on a cruise ship in the 14 days prior to arriving in Tasmania, must quarantine for 14 days on arrival in Tasmania. For more information on quarantine in Tasmania, please visit: https://www.coronavirus.tas.gov.au/travellers-and-visitors/quarantine-isolation-and-stay-at-home-directions • Overseas arrivals must be fully vaccinated and also have two COVID-19 tests while in quarantine – the first will occur within 48 hours of arrival, and the second will be on or soon after day 12 of quarantine. • Travellers who have spent time overseas (other than low-risk areas in New Zealand) or on a cruise ship in the 14 days prior to arriving in Tasmania require pre-approval from the Deputy State Controller to enter Tasmania. • The most effective way of seeking this pre-approval is to make a G2G PASS submission under 'Category 8: Other persons, or classes of persons, approved by the Deputy State Controller'. <p>For more information regarding G2G PASS, please visit: https://www.g2gpass.com.au/ and https://www.coronavirus.tas.gov.au/travellers-and-visitors/g2g-pass</p> <p>For more FAQs, please visit: https://www.coronavirus.tas.gov.au/travellers-and-visitors/g2g-pass/g2g-pass-faqs</p> <ul style="list-style-type: none"> • Please note that the COVID-19 situation can change at any time, meaning Tasmania's border restrictions and entry requirements could change at short notice. 	<p>QLD (Brisbane campus)</p> <p>As of 1am, Monday, December 13:</p> <ul style="list-style-type: none"> International arrivals must be fully vaccinated and return a negative covid test within 72 hours of departure They will be required to get a test on arrival They must go into home or hotel quarantine for 14 days <p>For more information on quarantine in Queensland, please visit: https://www.qld.gov.au/health/conditions/health-alerts/coronavirus-covid-19/protect-yourself-others/quarantine</p>
<p>6. When will I have face to face classes?</p>	<p>At AIBT, most schools are running online classes with a combination of e-learning and online consultations. We reopened our workshops and restaurants from 1 November 2021, and it's been estimated that face to face classes may resume early next year in 2022. Returning international students should contact their school directly about on-campus learning arrangements.</p>
<p>7. How can I update my OSHC information if I return to Australia earlier than my proposed course start date? (Overseas Student Health Cover)</p>	<p>If you arrive in Australia earlier than your proposed start date, you must contact your OSHC provider and make sure your OSHC covers the entire duration of your student visa (start date & end date). <p>8. Does college provide airport pickup and accommodation services?</p>	<p>Under current COVID-19 circumstances, we have temporarily suspended this service.</p>
<p>9. Will travel restrictions and quarantine requirements change? When?</p>	<p>Restrictions may change at short notice. All travellers should check requirements in the state or territory of arrival, including quarantine and testing requirements. For more information, visit: https://www.australia.gov.au/states</p>
