By accessing or in any way using the Aidbox FHIR API Module you are agreeing to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, you may not access or use the Aidbox FHIR API Module.

Health Samurai may change and update this Agreement from time to time, and will publish any changes on this page. Make sure to check this page for any updates. Your continued use of the Aidbox FHIR API Module after any such changes constitutes your acceptance of the new terms. If you are unable to comply with any amended version of the Agreement, you should stop use of the Aidbox FHIR API Module immediately.

## **PERMISSIBLE USE OF THE AIDBOX FHIR API MODULE**

We provide access to our application programming interfaces (“APIs”), including the Fast Healthcare Interoperability Resources API (“FHIR API”), the Consolidated Clinical Document Architecture API (“C-CDA API”), and any additional APIs of the Aidbox FHIR API Module. You may only access the Aidbox FHIR API Module by the means described in the documentation of the particular Aidbox FHIR API Module. If Health Samurai assigns you developer credentials, you must use them with the applicable Aidbox FHIR API Module. We may update, change, discontinue, or add APIs functionality or features to the Aidbox FHIR API Module at our discretion with or without providing notice to you.

You agree to comply with all applicable laws, regulations, and governmental issuances. You agree to provide and comply with a publicly accessible privacy policy.

## **RESTRICTIONS**

When using the Aidbox FHIR API Module, you may not (or allow those acting on your behalf to):

- Sell, lease or sublicense the Aidbox FHIR API Module or any data derived through the Aidbox FHIR API Module.

- Reverse engineer or attempt to extract the source code from any API or any related software.

- Perform an Action with the intent of introducing to the Aidbox FHIR API Module any viruses, defects, malware, or any items of a destructive nature.

- Interfere with or disrupt the Aidbox FHIR API Module or the servers or networks

providing the Aidbox FHIR API Module.

## **LIMITATIONS**

Health Samurai sets and enforces limits on your use of the Aidbox FHIR API Module, in our sole discretion, without notice or liability. Health Samurai reserves the right to:

Rate limit or block apps that make a large number of calls to the Aidbox FHIR API.

Disable, restrict or remove your app's access to the Aidbox FHIR API.

Change, suspend, or discontinue the availability of the Aidbox FHIR API at any time.

Impose limits on certain features or restrict your access to parts or all of the Aidbox FHIR API Module.

## **ACCOUNTS/REGISTRATION**

You represent and warrant that any and all registration information you provide to Health Samurai in connection with your access to the Aidbox FHIR API Module is accurate, complete, and up to date. Any notices in connection with this Agreement or your use of the Aidbox FHIR API Module will be provided by email to the address provided as part of your registration information. You agree to inform Health Samurai promptly of any updates to your registration information. You are responsible for maintaining the confidentiality of any Passwords, keys, tokens, and user IDs issued to you by Health Samurai in connection with your access to the Aidbox FHIR API Module (collectively, "Credentials") and agree not to provide them to any third party. You are responsible for all applications that are developed under your Credentials and any breach of security caused by your failure to maintain the confidentiality of your Credentials. ## **TERM, TERMINATION, SUSPENSION AND REVOCATION**
