1. General Product Description

Omnistrip[®] is made of a carded polyester-/polyamide skin-coloured non-woven, which is coated with an acrylic adhesive.

Omnistrip[®] has rounded ends, is conformable and stretchable, with a high porosity, permeability and breathability and good adherence to the skin.

Omnistrip® carries the CE mark according to EU directive 93/42/ EEC for medical devices. The product is classified as a class IIa medical device.

A conformity assessment has been performed for Omnistrip® and it has been shown to be in compliance with all applicable requirements of the above mentioned directive.

The safe use and effectiveness of Omnistrip®, therefore, is ensured if the product is used in line with the intended purpose.

2. Application / Indication

Omnistrip® is a wound closure strip, for atraumatic closure of minor wounds, surgical incisions in primary healing wounds; also to protect the wound margins against tension and stabilize fresh scars.
