- LOCATION:** Sleeman-Westfield Track,  
Ann Arbor Pioneer HS, 601 W Stadium, Ann Arbor, MI 48104
- DATE:** Thurs, May 22, 2015
- ENTRY FEE:** **\$150 per school or \$20 per athlete** (coach's honor), whichever is cheaper.  
**Be honest!** Make check payable to Pioneer Track Boosters
- AWARDS:** Medals to top 5 in individual and top 3 in relays;
- SCORING:** No team scoring. Please follow rules governing number of events!
- OFFICIALS:** Many of the workers are program parents and varsity athletes....  
Assistance offered in moving hurdles/blocks will speed the meet along!
- EVENTS:** Unlimited entries per event per each team-relays too!  
While we ask that you make your entries into the field events as well as relays, we do not require entries into the open track events! This allows maximum 'flex' in determining lineups-remember as there is no team scoring, you can give kids opportunities to experiment, shoot for that last PR, whatever! Even with that, you can make changes to relays and field events on meet day.  
HAVE YOUR KIDS KNOW A PR time for use in seeding for the track events!  
Additionally, you should not enter any state qualifiers into this meet!
- ROSTERS:** We need to have an electronic copy of your roster before the meet and will use athletic.net to obtain your roster. Please add this meet to your e-net calendar & then look for electronic updates once the season starts!
- FORMAT:** There are no prelims/semis. Relays lanes/heats are assigned randomly.  
**BE PREPARED TO BE PATIENT & FLEXIBLE!**
- RESULTS:** FAT will be used to record all finishes.  
Results available immediately after the meet & will be posted online too.
- GENERAL:** The purpose of the LAST CHANCE INVITE is to have a FUN, informal meet to offer those athletes who are **NOT** competing in the State Meet an opportunity to compete. Due to the potential for a LARGE amount of athletes, we may need your help in supplying workers, coaching ALL athletes (not just your own) & enforcing uniform/jewelry rules, etc.
- SCHEDULE:** **415p** PV: Starting at 7'0 with 6" raises  
HJ: Start at 5'0 raises of 3"  
LJ: 1 hour Open Pit: 4 jumps, no finals  
SP/DT: 4 throws, no finals  
*We will likely split schools in half: 1st half=DT & 2nd half=SP*
