4A District One/Two Bi-District (WesKing) Agreement 2022-24 (updated 10.3.22)

A. Formation of Agreement

- 1. Athletic administrators of the Kingco and Wesco Athletic Conferences served on the Bi-district Agreement Committee.
 - a. Kingco: John Appelgate, Lake Washington School District; Lance Gatter, Lake Washington School District
 - b. Wesco: Rory Rosenbach, Glacier Peak High School; Dani Mundell, Everett School District
- 2. The committee members processed proposals through their respective conferences to receive support.
- 3. The committee's goal was to develop an agreement that provides a fair, equitable, and exciting post-season experience for student-athletes and the communities each conference serves.

B. Sports included in this agreement

- 1. Team sports to be included in this agreement include the following:
 - a. Fall: Girls Soccer, Volleyball
 - b. Winter: Boys Basketball, Girls Basketball
 - c. Spring: Baseball, Softball, Boys Soccer
- 2. Individual sports to be included in this agreement include the following:
 - a. Fall: Cross Country
 - b. Spring: Track & Field

C. Sports not included in this agreement

- 1. Football The WIAA state format will be used
- 2. Slowpitch Softball Wesco does not currently offer
- 3. Swimming Each league will host their own District Meet
- 4. Bowling Current postseason process will be maintained
- 5. Gymnastics Current postseason process will be maintained
- 6. Golf Each league will host their own District Tournament
- 7. Tennis Each league will host their own District Tournament
- 8. Wrestling The WIAA regional format will be used

D. Entries to WesKing Events

- 1. The number of entries into WesKing events listed in this agreement are based on the following:
 - a. Ten (10) Kingco schools and five (5) Wesco schools meeting the WIAA standard of a team for allocation purposes.
 - b. Combined allocations of five (5) is based on District 1 receiving two (2) allocations and District 2 receiving three (3) allocations.
 - c. Combined allocations of four (4) is based on District 1 receiving one (1) allocation and District 2 receiving three (3) allocations.
- 2. In the event there are any differences in the numbers listed above, the Bi-District Committee will meet to determine if changes to the entry numbers are necessary.

E. Team Sports - Entries to WesKing Tournaments

1. Ten (10) team brackets will be utilized for all team sports.

- 2. In years the combined allocations to the state tournament total five (5) berths, Kingco will advance six (6) teams and Wesco will advance four (4) teams into the WesKing Tournament.
- 3. In years the combined allocations to the state tournament total four (4) berths, Kingco will advance seven (7) teams and Wesco will advance three (3) teams into the WesKing Tournament.

F. Team Sport Bracketing

- 1. Modified ten (10) entry brackets will be utilized for all team sports. Brackets will be adapted for each sport and are included as part of the agreement.
 - a. The 3rd and 4th place game will be played in all team sports.
 - b. In years the combined allocations to the state tournament total five (5) entries, the 5th and 6th place match will be played.
 - c. In years the allocations to the state tournament total four (4) entries, the 5th and 6th place games will not be played.

G. Seeding

1. Seeding for WesKing brackets shall be based on the finish within their respective league. Each league will determine their respective final order.

2. For soccer, Kingco #3 and Wesco #2 will play off, with the winner being the WesKing #4 seed and the loser being the WesKing #5 seed.

H. Individual Sports - Entries to WesKing Meets

- 1. Cross Country
 - a. In years the combined allocations to the state meet total five (5) berths, Kingco will advance six
 (6) teams and Wesco will advance four (4) teams into the WesKing Meet. Teams not qualifying will be permitted two individual entries in the WesKing Meet.
 - b. In years the combined allocations to the state meet total four (4) berths, Kingco will advance seven (7) teams and Wesco will advance three (3) teams into the WesKing Meet. Teams not qualifying will be permitted two individual entries in the WesKing Meet.

2. Track and Field

- a. The meet will be run as a timed finals event.
 - 1. There will be a total of sixteen (16) entries in individual events.
 - 2. Each school will be allowed one (1) team entry per relay event.
- b. In years the combined allocations to the state meet total five (5) berths, Kingco will advance six (6) individuals and Wesco will advance four (4) individuals into the WesKing Meet. The final six (6) entries in each individual event will be filled by the next six (6) best qualifying marks from each league qualifying meet.
- c. In years the combined allocations to the state meet total four (4) berths, Kingco will advance seven (7) individuals and Wesco will advance three (3) individuals into the WesKing Meet. The final six (6) entries in each individual event will be filled by the next six (6) best qualifying marks from each league qualifying meet.
- d. A schedule of events will be developed by representatives from each District.

I. Tournament sites

- 1. Tournament sites will be identified and agreed to by members of both Districts.
- 2. Game locations may be adjusted to accommodate match ups and reduce travel when possible and necessary. Changes shall be made by agreement of the Bi-District Committee.

J. Tournament/Meet Bulletins

- 1. WesKing Tournament/Meet bulletin templates shall be developed.
- 2. Sport tournament/event specific bulletins shall be developed by each tournament/meet manager in cooperation of members in each league, utilizing the template as a guide.

K. Tournament/Meet Managers

- 1. Each District will identify a league contact for each sport included in this agreement.
- 2. Each WesKing tournament/meet shall have a designated event manager(s).

L. Games committee

Each tournament game or site shall identify its games committee per WIAA guidelines. Each games
committee shall have a minimum of three (3) members with at least one member representing each
District. Exceptions to members on the committee may be made through agreement of the Bi-District
Committee.

M. Advancing to state

1. Teams will be seeded into state tournaments/meets per the current WIAA guidelines.

N. Financial

- 1. Finances for each WesKing event shall be managed by the District in which the host school is a member.
- 2. The net profit and loss of each WesKing event and/or other revenue and expense shall be shared proportionally among Districts.
 - a. Kingco's share will be two-thirds (2/3) of the profit/loss.
 - b. Wesco's share will be one-third (1/3) of the profit/loss.

O. Admission Prices/Passes

- 1. Ticket/Admission prices will be consistent with the approved admission prices for the District that event takes place.
 - a. For year 1 of the agreement, events held in District 1 will be \$8/\$6 and events held in District 2 will be \$7/\$5.
 - b. The host site of an event will determine the policy of digital tickets or cash sales or combination of digital/cash sales.

2. Accepted passes

- a. Washington State Coaches Association passes.
- b. Washington Secondary Schools Athletic Administration Association passes.
- c. Washington Officials Association passes.
- d. District One and Kingco "Supervisor Passes". These passes may be used at 4A Bi-District events at Kingco and Wesco sites.
- e. District One and Kingco "Lifetime Passes". These passes may be used at 4A Bi-District events at Kingco and Wesco sites.

P. Officials

Officials for each tournament event shall be assigned by the District in which the event is held. Each
District shall use its own process to assign officials, in cooperation with the Washington Officials
Association.

Q. Awards

- 1. Awards will be purchased by District 2, using the vendor of their choice.
 - a. Cost of awards will be shared proportionally between Districts, as outline in the financial section of the agreement.
- 2. Each team champion will be awarded a championship trophy.
- 3. For Cross Country and Track, ribbons will be awarded to individual placers in each event. The number of ribbons awarded will be based on the total state allocations for the event, either top 4 or top 5 finishers.

R. Addressing of grievances

- In the event either District feels this agreement or components of tournaments do not meet the needs
 and expectations of either party, a committee of members from each District shall meet to address all
 grievances. This agreement was negotiated in good faith and each party trusts the other to work
 collaboratively.
 - a. In the event the committee cannot mutually agree to a solution, the issue will be forwarded to the District Directors to determine a solution.
