What we do		

How does RightPath Servicing protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also contractually require third parties doing business with us to comply with all privacy and security laws.
How does RightPath Servicing collect my personal information?	 We collect your personal information, for example, when you apply for a loan give us your income information provide employment information or give us your contact information provide account information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Definitions	
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include companies with a RightPath Servicing or Mr. Cooper name; financial companies such as mortgage lenders; and non-financial companies, such as insurance agencies, technology service providers or direct marketers.
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. Financial service providers, such as mortgage bankers, securities broker- dealers and insurance agents &/or agencies. Non-Financial companies, such as retailers, direct marketers, membership clubs and publishers; and other companies and organizations, such as non- profit organizations.
Joint Marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include financial services and insurance companies.

Do Not Call Policy – This notice is the RightPath Servicing Do Not Call Policy under the Telephone Consumer Protection Act. We do not solicit via telephone numbers listed on the state or federal Do Not Call lists, unless the law allows.
