Notice Regarding Establishment of Overseas Subsidiaries in the United States and Spain

Arent Inc. (Headquarters: Minato-ku, Tokyo; CEO, President and Representative Director: Hiroki Kamobayashi) hereby announces that at a meeting of the Board of Directors held today, it has resolved to establish local subsidiaries in the United States and Spain in order to strengthen its overseas business foundation and accelerate global expansion. Details are as follows:

1. Purpose of Establishment

Arent, with the mission of "*Democratizing Tacit Knowledge*," promotes digital transformation (DX) in the construction industry. We operate under a dual-business model consisting of:

- **DX Services**, in which we collaborate with client companies to solve industry-specific challenges, and
- **Product Business**, which involves developing and offering proprietary SaaS products, as well as through M&A activities.

In recent years, Arent has expanded its product portfolio through strategic M&A, incorporating several solutions that address construction industry challenges, such as *PlantStream®*, *BUILD Ikkan Series*, *Genba Navi Schedule*, and *Shinseikun f Series*.

Among them, PlantStream®, a 3D CAD software specializing in automated plant piping design, has gained strong traction. Co-developed with Chiyoda Corporation and launched in 2020, the software significantly reduces the time required for piping design—from approximately two hours per pipe to the capability of generating up to 1,000 pipes per minute through intuitive operation. The solution has been adopted by leading domestic engineering firms including Chiyoda Corporation and JGC Corporation.

Internationally, adoption is expanding among global engineering firms such as Technip Energies, with the software now being used in approximately 16 countries (including indirect usage via subsidiaries).

In response to this growing global demand, we have resolved to establish local subsidiaries in the United States and Spain to enhance our product expansion capabilities abroad. The strategic significance of this decision includes:

- Establishing a framework for rapid response to global customers
- Localized technical support and implementation services
- Strengthening partnerships and sales channels
- Building a foundation for mid- to long-term product revenue growth

The new entities will be wholly owned subsidiaries of Arent Inc. and serve as central hubs for our international product operations.

The software is currently being adopted by more than 30 plant owners and engineering firms both in Japan and internationally.
