ASA Philippines Foundation, Inc. ("ASA Philippines", "company", "us", or "our") is dedicated to safeguarding the privacy of your personal data in accordance with Republic Act No. 10173, commonly known as the Data Privacy Act of 2012 ("DPA"), its Implementing Rules and Regulations, and all related issuances of the National Privacy Commission ("NPC").

This Privacy Notice outlines our policy in collecting, using, and processing personal data, including information transmitted to us in the course of official transactions and gathered from you through our alternative channels, such as, but not limited to, publicly accessible data processing systems and notifications displayed at our reception area during events where the participants' personal data is/are collected through attendance sheets or registration forms, as required by the NPC. The terms of this Privacy Notice cover all our operations in our branches in the Philippines. Your personal information controller is ASA Philippines. In other words, ASA Philippines is responsible for collecting, processing, and protecting your personal data.

# USES OF, PURPOSE AND BASIS FOR PROCESSING OF PERSONAL DATA

The collection of your personal information is necessary to help us develop, deliver, and improve our products and services, including the following:

- Fulfillment of transactions and purchase and/or availment of our products and services;
- Documentation and processing of inquiries and requests addressed to ASA Philippines, ensuring proper forwarding to the relevant internal units for action, and response;
- Solicitation of the feedback for the products and services we offer;
- Fulfilling legal obligations imposed on ASA Philippines;
- Promoting the products and services of ASA Philippines;
- Complying with public order and safety requirements or performing public authority functions, including processing personal data to fulfill ASA Philippines' charter; and/or
- Facilitating appropriate actions in response to data subjects' requests related to their data privacy rights.

The personal data collected from you is necessary for the fulfillment of your transaction with us and pursuant to our legitimate interests, in consonance with our organizational charter.

## OTHER USES OF PERSONAL INFORMATION

From time to time, we may use your personal information to send important notices and advisories, such as communications about the services that you may have availed and ongoing promotions. We may also use your personal information for internal purposes, such as auditing, data analysis, and research to improve our products, services, and customer communications.

# MANNER OF STORAGE OF PERSONAL INFORMATION

We store your personal information on our computers and servers maintained in a secure environment and protected by the appropriate encryption protocols and authentication controls, which are designed to manage and restrict access strictly to authorized personnel.

Your personal information may likewise be stored with third-party data storage providers using cloud-based services, which is similarly protected by the appropriate encryption protocols and authentication controls. We commit to implementing appropriate measures to safeguard your information.

## ACCESS TO COLLECTED PERSONAL INFORMATION

You are also made aware that we, including our affiliates, employees, agents, and third-party service providers (payments and data analytics), may access and share this personal information with each other and use it consistently with the purpose of your availed services and with the terms of this Privacy Notice.

For your guidance, the personal data which we process is not shared with any other party unless such disclosure is allowed under Sections 12 or 13 of the DPA, whichever is applicable.

## RETENTION AND DISPOSAL OF YOUR PERSONAL INFORMATION

Personal data will be retained in our secure database for a duration of two (2) years after the last transaction or resolution of inquiries and requests, or until the expiration of the retention limits set by applicable laws, whichever comes later. These records shall thereafter be permanently deleted in accordance with our disposal policy.

Where applicable, when it is no longer reasonably required for the above-related purposes or when you withdraw your consent (where applicable), provided that we are not legally required or otherwise permitted to continue to hold such data, we likewise commit to permanently delete your personal data in accordance with our disposal policy.

All documentation of personal information shall be permanently deleted after the lapse of the retention period. Additionally, once permanently deleted, your personal information cannot be recovered.

#### PROTECTION OF YOUR PERSONAL INFORMATION AND RISKS OF PROCESSING

Our company takes your privacy seriously and shall implement appropriate organizational, physical and technical security measures in our systems in order to maintain the highest levels of security and protection, which likewise undergo upgrading when necessary. When in transit, digital information shall be protected using encryption and authentication. These security measures aim to maintain the availability, integrity, and confidentiality of personal data and protect them against natural dangers such as accidental loss or destruction, and human dangers such as unlawful access, fraudulent misuse, unlawful destructions, alteration, and contamination.

Some of the measures we put in place include:

- Access control policies implemented in both digital and physical infrastructures to prevent unauthorized access to personal information;
- Acceptable use policies;
- Application of end-to-end encryption and data classification, whenever appropriate;
- Implementation of security measures to mitigate risks related to natural disasters, power disturbances, external access, and similar threats; and
- Employment of technical measures to safeguard our computers and databases against accidental, unlawful, or unauthorized usage, interference, or access.

#### METHODS UTILIZED FOR AUTOMATED ACCESS

You also understand that ASA Philippines employs a third-party service provider to analyze the data traffic on our website in order to aid our assessment of our website engagement and to enhance our services and features.
