

SUPPLEMENTARY DECLARATION BY AUTHORISED OFFICER

I, Paul Farrow, National Secretary, of Level 2, 16 – 20 Good Street, Granville in the State of New South Wales, do solemnly and sincerely declare:

1. I am the National Secretary of The Australian Workers' Union (**'the AWU'**).
2. The AWU is an organisation of employees registered under the *Fair Work Act 2009* (Cth) and I am authorised to make this Supplementary Declaration on its behalf.
3. On the 25th of July 2025, the AWU filed a *Form F68 – Application For Consent to the Eligibility Rules of an Organization* (**'the Application'**) for an alteration to the AWU Rules (**'the Rules'**).
4. The application proposed an alteration to the AWU's Rules, specifically to insert a new sub-paragraph (k) within Rule 5, Section 6, Part Q (32) (with the current sub-paragraph (k) to become sub-paragraph (l)), to enable the AWU to cover and represent employees engaged in skydiving operations.
5. I provided a declaration in support of the Application dated the 16th of July 2025, which was annexed to the Application as Annexure AWU-5 (**"Declaration"**).
6. At paragraph 5. of the Declaration, I stated as follows:

"5. The alterations are made consistent with the requirements of section 159 of the Fair Work (Registered Organisations) Act 2009 ('FW (RO) Act') in that they:

- a. comply with and are not contrary to the FW (RO) Act; the Fair Work Act 2009, modern awards and enterprise agreements;*
- b. are not otherwise contrary to law; and*
- c. are made under the Rules".*

7. I understand that I referred to the incorrect section of the FW (RO) Act in that Declaration.
8. Accordingly, I confirm that the alterations to the Rules in the Application are made consistent with the requirements of section 158 of the FW (RO) Act and Regulation 121 of the *Fair Work (Registered Organisations) Regulations 2009* (**Regulations**).
9. I further confirm that the alterations:
 - a. comply with and are not contrary to the FW (RO) Act, the Regulations, the *Fair Work Act 2009*, modern awards and enterprise agreements;
 - b. are not otherwise contrary to law; and

c. are made under the Rules.

10. This Supplementary Declaration will be posted on the AWU's website with the Application (containing the Declaration) as soon as practicable after filing.

Particulars

11. The particulars set out in this Supplementary Declaration are true and correct to the best of my knowledge and belief.

AND I MAKE this solemn declaration by virtue of the *Statutory Declarations Act 1959* (Cth) and subject to the penalties provided by that Act for the making of false statements in Statutory Declarations, conscientiously believing the statements contained in this declaration to be true in every particular.
