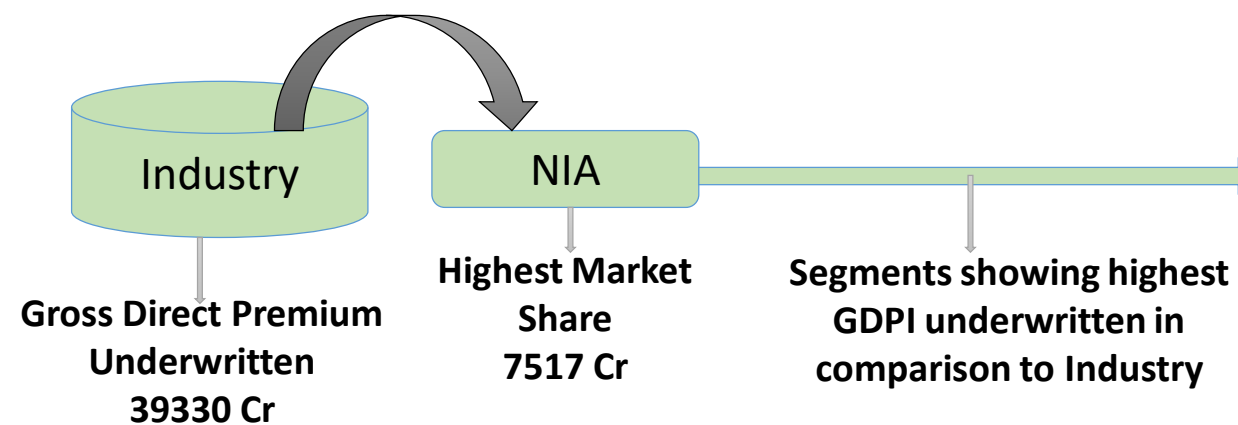

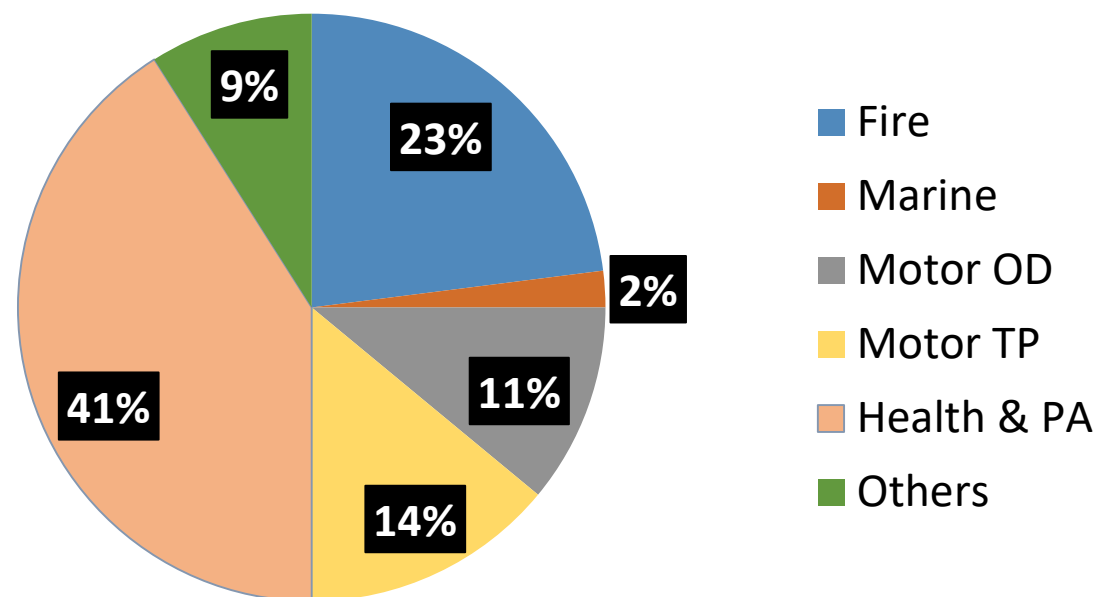

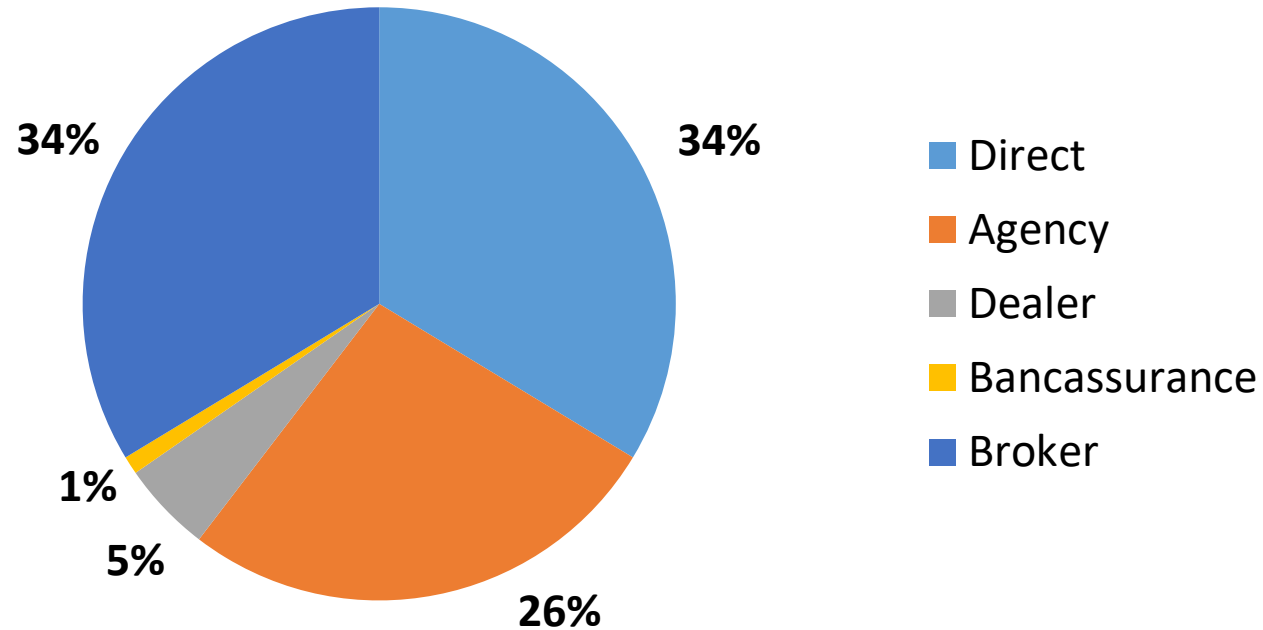
Business Mix – Global GWP Q1 FY20-21

Gross Written Premium 8368 Cr

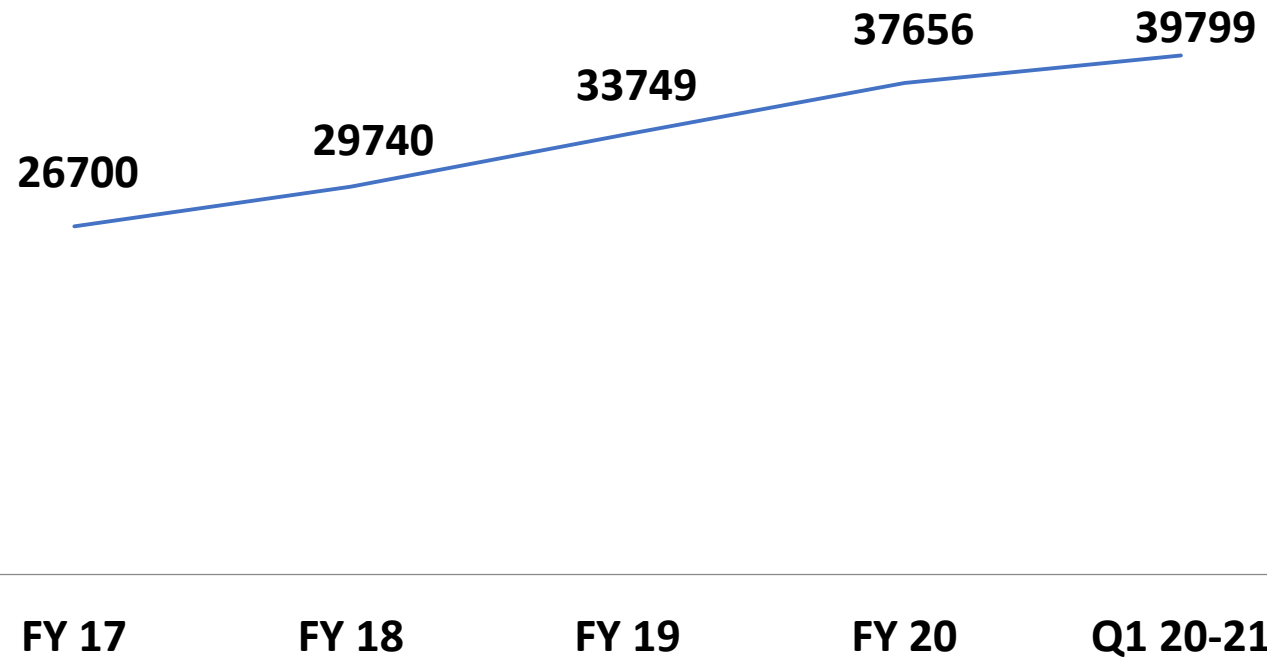


Distribution Mix – Indian Business Q1 FY 20-21

Channel Mix



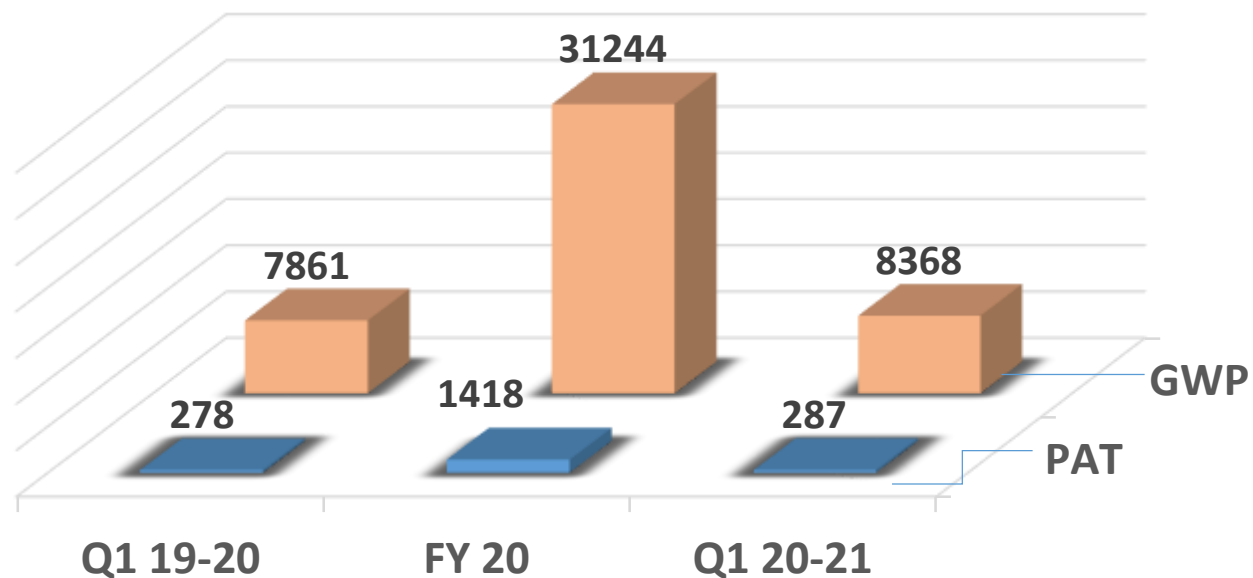
Movement in Technical Reserves (Cr)

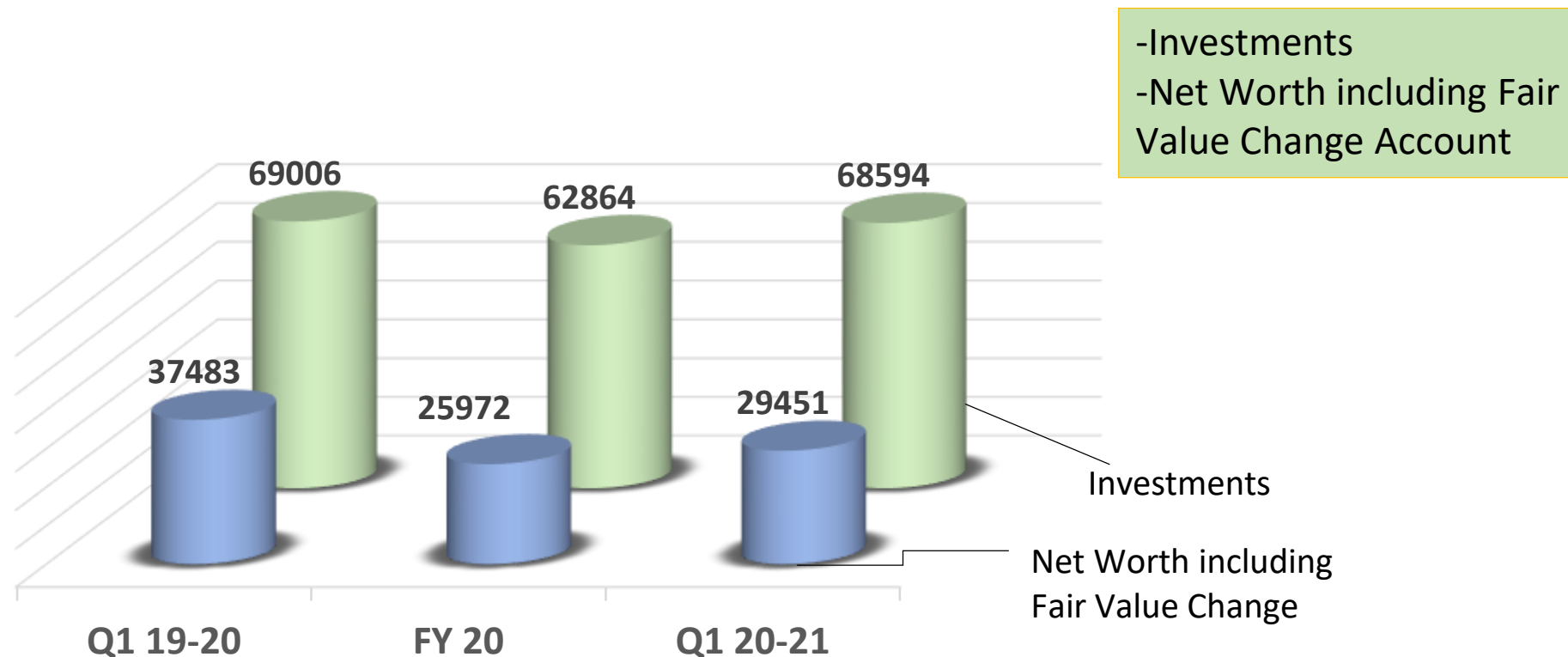

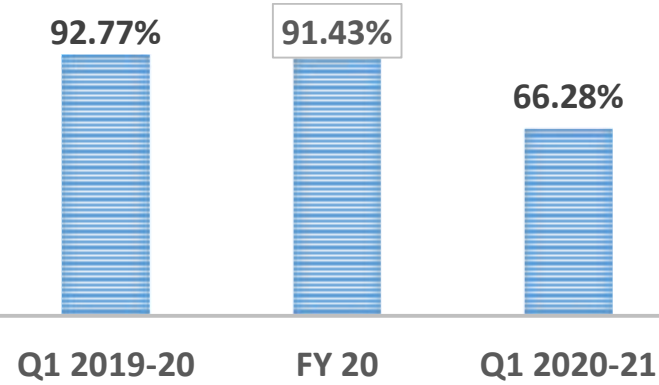

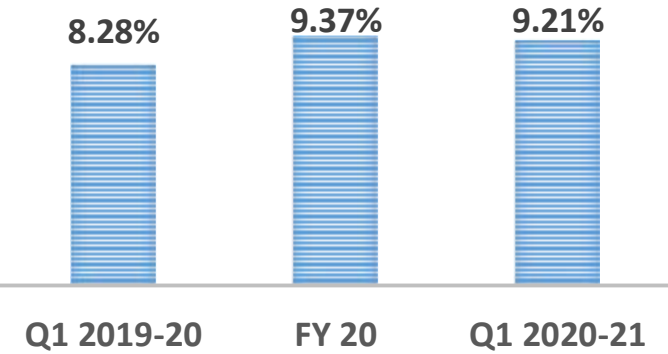

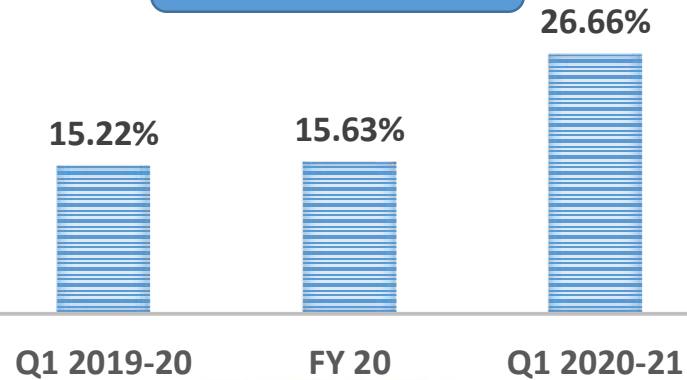
Incurred Claims Ratio



Commission Ratio

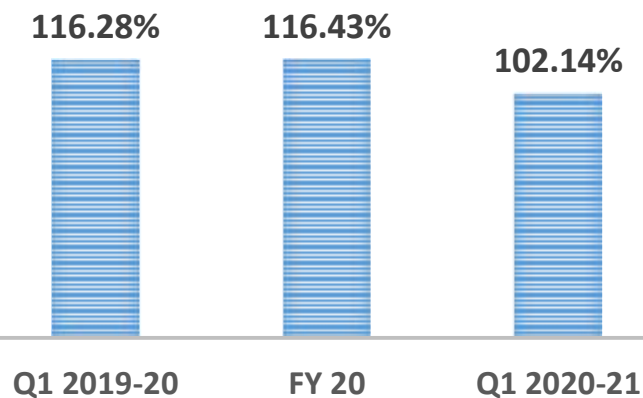


Expense Ratio

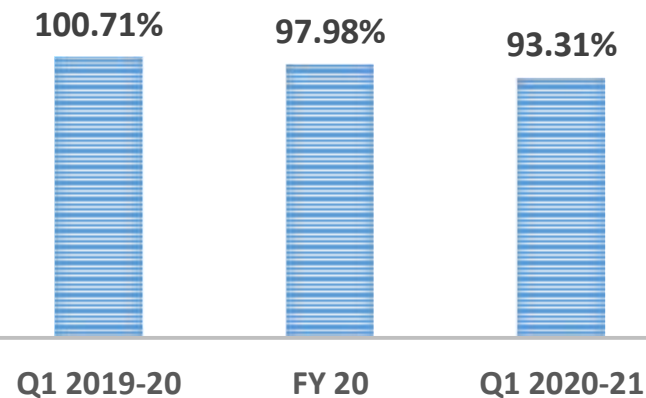

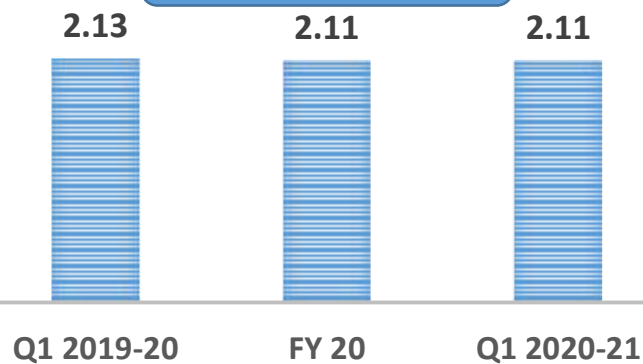
Combined Ratio



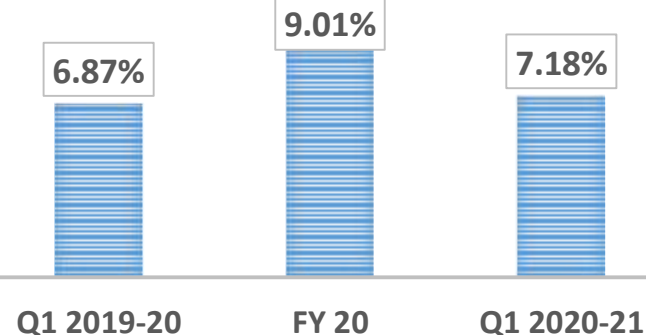
Adjusted Combined Ratio
