

# KEY UPDATES

- The entire circuit had become operational in the Q3 FY 22 with Maharashtra allowing cinemas to commence operations from 22<sup>nd</sup> October onwards.
- Content flow from Bollywood film industry commenced post Maharashtra re-opening, resulting in business witnessing robust demand in the months of November and December 2021.
- The quarter was marked with strong performances from movies such as Sooryavanshi, Annaatthe, Eternals (during November'21), Spiderman : No way Home, Pushpa and 83 (during December'21), delivering excellent box office collections.
- The business delivered positive operating margin in Q3 with EBITDA of INR 6,617 lacs; and **stopped burning cash after 6 quarters.**
- **The EBITDA margin (*adjusted for IndAS 116*) for the month of December 2021 was 23.7%.**
- The 3<sup>rd</sup> wave of Covid -19, fuelled by the Omicron variant, has further delayed the business recovery with certain states re-imposing restrictions on operations. This has resulted in blockbuster content such as Jersey, RRR, Prithviraj etc deferring release.
- The company continues to remain strong financially with liquidity of INR 74,158 lacs as at the end of December 2021.



% Weekly footfalls vis à vis average weekly footfalls for Pre Pandemic period (average of FY'20)\*





# Q3 FY 22 : ROBUST REALIZATIONS RESULTED IN STRONG RECOVERY



- Q3 FY 22 was the best quarter in the last 7 quarters with Bollywood movie release calendar starting in Nov'21.
- There was month on month improvement in operating performance driven by strong growth in Admits, Ticket Price and SPH. Even though the admissions were 145 Lacs during the quarter (lower by 44% as compared to Q3, FY 20), higher ATP of INR 239 (+14%) and SPH of INR 129 (+28%) resulted in much stronger revenue recovery.





- December 2021 witnessed strong business recovery with Exhibition revenue and EBITDA margin being very close to Pre Pandemic levels.
- Even though the admissions were 65.5 Lacs during the month (lower by 25% as compared to December 2019), higher ATP of INR 255 (+20%) and SPH of INR 128 (+22%) resulted in revenue being only 8% lower than December 2019.
- Advertising income, as anticipated continues to lag in recovery as compared to F&B & Box Office income.



## Variable Expense Analysis







CAM (INR Lacs)








**Personnel cost (INR Lacs) & Head Count**

## Personnel

- Personnel cost has increased on account of increase in cinema operations in Q3 FY 22. However, it is still significantly below pre pandemic levels.
- Head count is 28% below the pre pandemic levels.
