

## Privacy Statement

Autosociaal B.V. (Here in after "Autosociaal") respects and protects the privacy of all visitors of its Application (here in after "Application"). Autosociaal uses all personal information provided only for purposes that are defined in the Privacy Statement. The legal relationship between you and Autosociaal is governed by Dutch law and the processing of personal data is therefore in accordance with applicable Dutch laws in the area of privacy, in particular the Personal Data Protection Act.

### 1. What is the application?

This application is a product of Autosociaal. Autosociaal is the company that operates the Application. The Application is the mobile extension of a car / garage company as well as a connection platform between a car user and a car company. All this in terms of and with the appearance of the trusted car / garage company.

### 2. Which data is processed by Autosociaal?

If you wish to register in the Application, your name and e-mail address will be processed. This can be enriched later with name, address details and license data. These will also be processed by Autosociaal.

### 3. With what purposes does Autosociaal process data?

Your name and e-mail address will be processed to provide you with information that has been compiled by your car / garage company.

### 4. To whom does Autosociaal provide information?

Autosociaal will not share or disclose your data to third parties without your permission, unless directed to it by law. However, Autosociaal may provide (a part of) your information to companies that are affiliated with the Application.

Autosociaal reserves the right to provide (part of) your information in case of transfer of ownership of (a part of) the Application, for example by a merger or acquisition by another company. Autosociaal will endeavor to inform you if your information is provided to the acquiring company, for example, by a notice in the Application or advertisement in a national newspaper.

5. What is the extent of the responsibility of Autosociaal?

The Application contains links to third party Applications. Autosociaal is not responsible for compliance with the privacy laws by these third parties.

6. How does Autosociaal protect your data?

Autosociaal carries out appropriate technical and organizational measures to protect your personal data against loss and against any form of unlawful processing.

7. What rights do you have?

You have the right to ask Autosociaal what personal data it has processed from you. Autosociaal will respond in writing to this request within four weeks. Then, you can request Autosociaal to add, improve, remove or shield this information, with your request indicating what changes you want. Autosociaal will respond to this request at least within four weeks.

8. Can this Privacy Statement be changed?

Should Autosociaal decide to change its Privacy Statement, these changes will be included directly in this Privacy Statement.
