### Did you know, that ...?

Each country has its own peculiarities in terms of documents, employment and legal regulations. Here are some Austrian pecularities:

#### **Documents:**

In order for a work permit to be issued, foreign certificates must be translated into German, usually. This may only be done by sworn interpreters.

#### Visa D:

A work visa "D" is not sufficient to start work. A work permit from the Labor Market Service is also required.

#### Wages and salaries:

The level of wages and salaries cannot be determined freely. Statutory minimum wages must be taken into account. In a normal employment relationship, wages and salaries are to be paid 14 times a year.

#### **Business Manager:**


In Austria, special provisions apply to managing directors who comply with the trade regulations. For example, the managing director's place of residence must be close to the company.
