**RECIPIENTS OF PERSONAL DATA** Your personal data may be disclosed to entities providing services that require data processing on our behalf, including software providers, postal operators, and telecommunications providers. Your data may also be disclosed to public authorities authorized by law to obtain such information.

**YOUR RIGHTS** You have the right to access your data, request its rectification, erasure, restriction of processing, or data portability. You also have the right to object to the processing of your personal data where it is carried out based on our legitimate interest or the performance of a task in the public interest.

If your data is processed based on consent, you have the right to withdraw that consent at any time. Withdrawal of consent does not affect the lawfulness of processing carried out before its withdrawal.

In addition to the above rights, you have the right to lodge a complaint with the President of the Personal Data Protection Office (Prezes Urzędu Ochrony Danych Osobowych) **PROVISION OF DATA** Providing your personal data is voluntary but necessary to achieve the purposes of processing, including participation in the event (except for data processed based on consent – such data is not required for participation).

**AUTOMATED DECISION-MAKING** No decisions will be made about you based solely on automated processing of your personal data.
