

The UNECE officially announced technical regulations UN R151 related to the Blind Spot Monitoring System and the technical regulations UN R159 related to the Moving Off Information System. Both regulations have come into force.

CSMS/SUMS

Vehicles Cybersecurity and Software Update

UNR155/156 require that measures be implemented to manage vehicle cyber risks, secure vehicles by design to mitigate risks along the value chain, detect and respond to security incidents across vehicle fleet, prove safe and secure software updates and ensure vehicle safety is not compromised.

DDAW

Driver Drowsiness and Attention Warning System

Driver Drowsiness and
Attention Warning (DDAW)
systems monitor a driver's
level of drowsiness and alert
the driver through the vehicle
Human Machine Interface
(HMI). Any processing of
personal data in DDAW system
shall be carried out in
accordance with Union data
protection law.

ADDW

Advanced Driver Distraction Warning System

Regulation (EU) 2019/2144 (new GSR) requires that to prevent visual distraction-related crashes, the regulation mandates the implementation of Advanced Drivers
Distraction Warning (ADDW) systems for new types of vehicles from 2024.

ISA

Intelligent Speed Assistance

On June 23, 2021, the European Commission adopted the final draft regulation for the ISA Intelligent Speed Assistance system. On November 17, 2021, the regulation was officially published as Regulation No. (EU) 2021/1958.

New Technology Homologation Solutions

ELKS

Emergency Lane Keeping System

The new GSR Regulation 2019/2144 stipulates that from July 6, 2022, all new type of M1 and N1 vehicles must install the Emergency Lane Keeping System (ELKS) and comply with Regulation (EU) 2021/646. ELKS is a driving assistance system that should warn the driver and correct the trajectory when the driver accidentally leaves.

AEBS

Advanced Emergency Braking System

Automotive AEBS system is also known as Advanced Emergency Braking System. According to the new framework regulation of EU 2019/2144, starting from July 6, 2022, all new M1, N1 type vehicles entering EU market in unlimited series shall equipped with Car-to-Car AEBS function.

ADAS

Advanced Drive Assist System

According to the UN R79 regulation, vehicles equipped with ACSF, CSF, and ESF functions need to be tested and obtain type approval certificate of R79 before entering EU market.

BattG

Batteries Regulation

Regulation (EU) 2023/1542 of the European Parliament and of the Council of 12 July 2023 concerning batteries and waste batteries, amending Directive 2008/98/EC and Regulation (EU) 2019/1020 and repealing Directive 2006/66/EC. The implementation date is February 18, 2024.

VECTO

VECTO/HDV Emission Simulation

Due to the diversity of configurations and testing challenges associated with HDVs, the EU has opted for a computer simulation-based approach, known as VECTO (Vehicle Energy Consumption calculation TOol), to determine emissions and energy consumption.


