



Data Protection Notice for

Cluster Summit Finland 2025 & Cluster Collaboration Lab (C2Lab)

28 – 30 October 2025, Kuopio, Finland

Your personal data is processed in accordance with **Regulation (EU) No 2018/1725¹** on the protection of individuals with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

The data controller of the processing operation is the Head of Unit I.0.2 (SMP/SME Pillar) of the European Innovation Council and SMEs Executive Agency (EISMEA).

The following entities process your personal data on our behalf:

The legal basis for the processing activities are:

- Article 5(1)(a) of Regulation (EU) 2018/1725 because processing is necessary for the performance of a **task carried out in the public interest** (or in the exercise of official authority vested in the Union institution or body)² laid down in Union law.
- Article 5(1)(d) of Regulation (EU) 2018/1725 based on your **explicit prior consent** for your non-mandatory personal data indicated below.

The purposes of this processing are to:

- register and manage your registration to the “Cluster Summit Finland” and “C2Lab” event on 28-30 October 2025;
- include you in the list of participants;
- facilitate information about your registration and approval to the event;
- contact the participants in order to prepare for the event and manage the activities of the event;
- analyse your feedback about the event and provide related follow-up activities such as satisfaction surveys, communication concerning the event, post-event communication, invitation to next editions, management of lists and mailing lists for contacts, presentations, and/or audio and video recording of speakers and participants;
- include data in the participants’ list, which will be shared with other participants of the event on the B2Match platform to allow online networking, and for internal statistical reporting.

The following of your personal data are collected:

- First name, last name, phone number, email address, job title/position, entity name, country, region, attendance of agenda points of the event, interest areas regarding the project work, pitching session, dietary restrictions, IP address.

These elements are mandatory for the purposes outlined above.

In addition, the following **non-mandatory** personal data may be collected: your photos, videos, your LinkedIn/X/Facebook account, which you may have the opportunity to provide if you want and will only be processed based on your explicit prior consent.

The collected personal data might also be communicated to bodies in charge of monitoring or inspection tasks in the application of Union or national law (e.g., internal audits, Court of Auditors, European Anti-fraud Office (OLAF), law enforcement bodies).

The participants list will be distributed through a dedicated web-based matchmaking tool and a dedicated event booklet to all the participants and will include the following information: first name, last name, professional e-mail address and entity.

Your personal data will be transferred to Savonia University of Applied Sciences and North Savo Regional Council exclusively for purposes directly related to the organisation and facilitation of the Cluster Summit Finland and the C2Lab event in Kuopio. This may include, but is not limited to, access management, security protocols, and coordination of activities or institutional visits, should such visits be included in the programme. The transfer of personal data will be carried out in compliance with applicable data protection laws, ensuring that your information is handled securely and solely for specified purposes.

The following **third-party tools** will be used for the organisation of this event:

2. For the purpose of facilitating the info session, **Zoom, a third-party tool managed by LOW Associates Brussels SRL**, will be used. Moreover, it hosts the general collected personal data on servers in the United States for video calls; it hosts meetings with data centres in Germany and Netherlands. 3. For the purposes of asking questions to the participants during the event, **Slido, a third-party tool managed by Asociación IDiA**, will be used. Please visit this link for more information regarding the Slido privacy statement: [Privacy Statement Slido](#). The use of Slido during the event does not require the participants to register. The users can decide themselves whether they would like to provide names. If yes, those names are collected. Provided names are used by default when submitting questions and poll votes, but participants can still choose to be anonymous. If no name is provided, participants will be anonymous.

Your personal data **will not be transferred** to third countries or international organisations with the exception of data collected by third-party tools (*B2Match, Zoom*) with their own privacy policy, which you are strongly suggested to read carefully.

Zoom user-generated information is stored in the data centre in the United States as provided during the ordering process. Data is replicated across data centres within the same region to ensure availability. Zoom, inc. data, which utilises Host and Usage Information, is stored in the Netherlands and Germany. The processing of your data will not include **automated decision-making** (such as profiling). The following technical and organisational security measures are in place to safeguard the processing of your personal data:

- All personal data in electronic format (e-mails, documents, databases, uploaded batches of data etc.) are stored on the servers of EISMEA, the European Commission (and of its contractors if contractors are engaged to assist the controller in the organisation and management of meeting(s) or event(s));
- All processing operations are carried out pursuant to Commission Decision (EU, Euratom) 2017/46 of 10 January 2017 on the security of communication and information systems in the European Commission;
- In order to protect your personal data, EISMEA and the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into account consideration the risk presented by processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of given processing operations.
- EISMEA and Commission contractors are bound by specific contractual clauses for any processing operations of your personal data on their behalf and by the confidentiality obligations deriving from the General Data Protection Regulation ('GDPR' – Regulation (EU) 2016/679).

Your personal data will be kept for a maximum period of 48 months after the event. Data will be manually deleted at the end of this period.

The personal data may be further processed for historical, statistical or scientific purposes. The further retention time for this purpose will be 10 years after the end of the Single Market Programme (SMP).

You have the right to access your personal data and to request your personal data to be rectified, if the data is inaccurate or incomplete; where applicable, you have the right to request restriction or to object to processing, to request a copy or erasure of your personal data held by the data controller.

If processing is based on your consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of the processing based on your consent before its withdrawal.

Your request to exercise one of the above rights will be dealt with without undue delay and within **one month**.

Your right to information, access, rectification, erasure, restriction or objection to processing, communication of a personal data breach or confidentiality of electronic communications may be restricted only under certain specific conditions as set out in the **applicable [Restriction Decision](#)** in accordance with Article 25 of Regulation (EU) 2018/1725.
