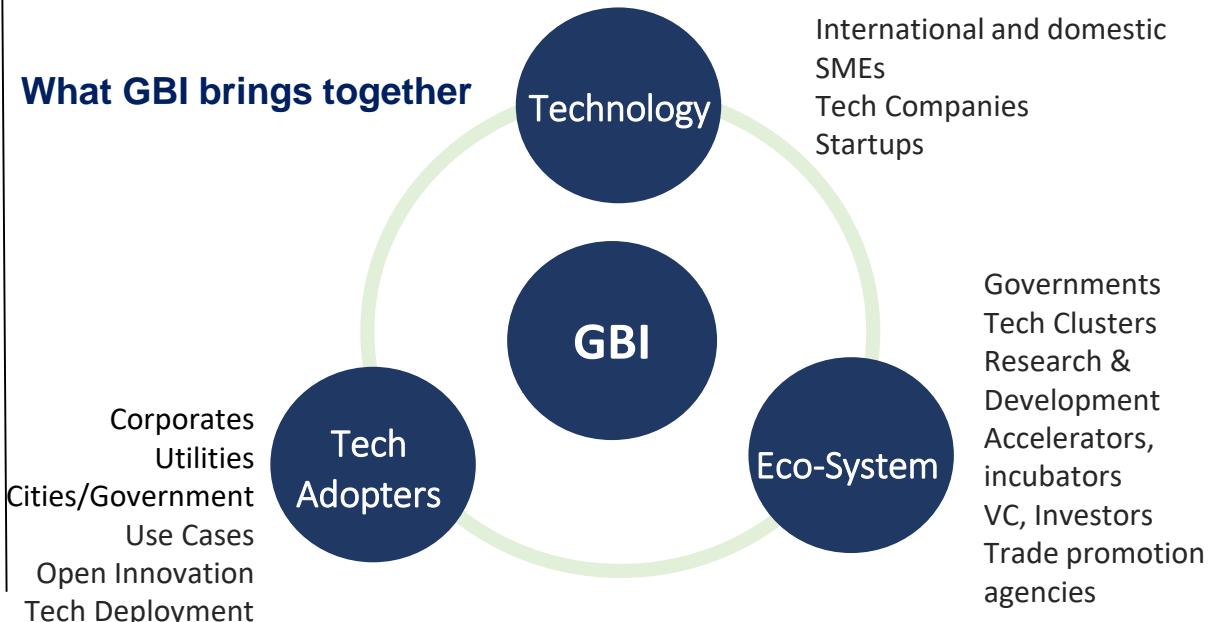

Biotechnology Industry Research Assistance Council (BIRAC) engaged Global Business Inroads (GBI) as international facilitation partner for Global Bio-India 2024 to facilitate global participation. As partners of BIRAC, GBI coordinated a mission of International Biotech start-ups and ecosystem stakeholders to India during **Global Bio-India, 12th-14th September 2024 and 4th-6th Dec, 2023 at Bharat Mandapam, New Delhi.**

GBI facilitated the international participation of 31 participants from 15 countries in 2024, featuring

- 15 biotech companies,
- 5 incubators/accelerators/universities,
- 3 investors, and
- 4 global panel speakers.
- The 15 participating countries included Sweden, USA, Japan, UK, Colombia, Hungary, Czech Republic, Israel, Serbia, Poland, Sri Lanka, Bulgaria, Malaysia, France, and Netherlands.

GBI also facilitated a “**Global Panel Roundtable**”. The roundtable aimed to provide an interactive forum where representatives from international embassies, national governments, and country representatives showcased their region’s expertise and explored opportunities for cross-border partnerships in the area of biotechnology with a focus on promoting bio innovation and biomanufacturing..

EU Case Studies

EU & India Electric Vehicle Battery Recycling Technologies Exchange 2024 - EEN

GBI collaborated with the **Delegation of the European Union to India** in cooperation with The **Office of the Principal Scientific Adviser to the Government of India** on an initiative to enhance collaboration between EV battery recycling solution providers and adopters from the EU and India.

The goal was to facilitate the exchange of innovative solutions, foster impactful partnerships, and support the deployment of cutting-edge technologies. This was organized under the umbrella of the **EU-India Trade and Technology Council (TTC)**.

- **6 EU and 6 Indian technology SMEs and start-ups were shortlisted** and pitched to a panel of experts on June 20.
- From the six start-ups, three start-ups were selected to visit Electric vehicle battery recycling facilities and meet with stakeholders in India and EU respectively.
- Access and insight into the broader EV landscape of India and EU.
- Ecomet – EU-India EV battery recycling
- For Indian start-ups – EEN nodes shared EOIs and AWEX and Brabant region clusters received the mission.
- GBI supported the companies with market access and partner/project identification in India.



- The program aimed to provide an opportunity for Indian startups to access Europe through the Walloon/Belgian ecosystem, which was identified as a key CleanTech/Life Sciences Hub
- The call was facilitated on the Global Technology Interface (GTI ®) platform, 41 innovative Indian startups applied for the program out of which 17 startups were shortlisted to pitch to a jury of experts in New Delhi and Hyderabad.
- Virtual capacity building sessions were conducted for the startups.
- **6 companies were selected for a physical immersion trip**
- These six companies **visited Wallonia from Dec 4th -8th, 2023**, where they benefited from a tailored business program designed to meet their specific needs and projects.
- Through B2B meetings and informative sessions, participants had the opportunity to connect with potential business partners, particularly in Wallonia, and explore the viability of establishing a European presence.
- **Mestastop Solutions** established a European subsidiary in Wallonia, Belgium in May 2024

EU-India Innovation Cooperation in the Biofuels Sector

Objective:

GBI has executed a 9-month research and innovation project in collaboration with the European Commission to increase cooperation between the EU and India in the biofuels sector. The project focused on three areas: **Advanced Biofuels for 1) Aviation, 2) Maritime transport 3) from biomass**. Stakeholders across the supply chain and air and marine transportation ecosystem from EU and India were involved in this pilot initiative.

Scope of Work:

- Research and Mapping of India Biofuels Sector and Stakeholders, Opportunities and Challenges was carried out by GBI and a report was prepared to build knowledge amongst policymakers, business and financial institutions.
- Through a series of interactions, meetings and awareness raising events in 2023 the project showcased and connected the European and Indian advanced biofuel ecosystem, **challenges and opportunities in technology, market, innovation, and funding** to strengthen the ongoing collaboration for clean and sustainable growth.
- **15+ EU-India B2B and B2G meetings were organised**
- Connected and facilitated meetings between a **German company Muenzer to Pandit Deendayal Energy University (PDEU) in Gujarat, India**, to work with them to manage the biggest challenge in biofuels projects, i.e. – feedstock supply. In collaboration with PDEU, Muenzer will set up a process to collect feedstock in Gujarat State and set up a used cooking oil to biofuel plant in PDEU campus.



EU-India Thematic Workshop for Promotion of Investment in the Digital Sectors

The EU Delegation commissioned GBI to **research and publish 4 thematic reports**. The process included consultative focus group meetings that lead to the mapping respective ecosystems' strengths, gaps, initiatives, activities and opportunities for EU-India business and investment.

- Post which GBI also **organized 4 thematic workshops** to present, validate and complement the findings and conclusions of the studies and focus groups. The workshops were organized a part of the Digital Investment Forum (DIF), **on the side-lines of the first EU-India Trade and Technology Council (TTC) meeting which took place on 16 May, 2023 in Brussels**.
- **150 stakeholders registered and participated** across all the four workshops.
- The four reports and the consultative workshops were well received by a diverse group of participants that included EU and Indian corporates, SMEs, start-ups, universities, R&D organisations, representatives of EU Member States, business associations & networks, amongst others. **The workshops resulted in validating the reports and the audience appreciated the findings.**



Twinning Innovation Projects



EU-India Innovation Partnership (EIIP)

- EIIP was launched as a pilot initiative in April 2018 with the aim to strengthen the innovation dimension of EU-India Cooperation.
- It promoted the exchange of ideas and a mutual understanding of each side's innovation ecosystems.
- This facilitated co-creation and the development of new and innovative products and services.
- Through this pilot initiative, the EIIP network created an active community of incubators, accelerators, start-ups, investors, corporates and public sector organizations.

EU-Sri Lanka Innovation Partnership (EUSLIP)

- This initiative aimed to connect the innovation and start-up ecosystems in Europe, India and Sri Lanka.
- A network of incubators and accelerators from Europe, India and Sri Lanka were supported with networking to explore opportunities for matchmaking, scaling up, co-creation, co-development and co-investment for incubators, accelerators and start-up entrepreneurs and innovators.
- The EU-South Asia Start-up Help Desk - Hands-on Support was provided to selected startups for internationalization.
- EU-South Asia Investor Networking Platform - connected the three major angel and investor networks with the objective to explore cross-border investments.
- EU-South Asia Corporate Innovation Platform - Corporates were invited to share problem statements and scout for start-ups.



Cross-border Innovation Programs: textiles, circular fashion, digital, medtech



As a significant contributor of greenhouse gases resulting in climate change, the fashion industry needs to act to cut its gas emissions as clothes, footwear and household textiles are responsible for water pollution, greenhouse gas emissions, and landfill.

GBI coordinated a multi-stakeholder interaction focused on:

- **Sharing of knowledge and best practices**
- Co-development of sustainable products (challenges and opportunities were explored)
- Digitalisation as a path to achieve sustainability
- Policy development

A total of 85 stakeholders participated and 36 networking and B2b meeting were recorded.

The Innovate for Digital India Challenge 2.0

- GBI worked with the Department of Science and Technology (DST), Govt of India on the Innovate for Digital India Challenge 2.0, to support 10 Indian start-ups with India and US market acceleration.
- With GBI's support, USMAC planned and, implemented the US market access program, consisting of a 4-day boot camp, virtual mentoring for 4 weeks and a 15 day Soft landing program in Silicon Valley for the selected Indian start-ups.



EU - India & Sri Lanka - Digital MedTech

- In association with the Start-up Campus Germany and EEN – Hungary, GBI organized a virtual tour to help EU MedTech companies to understand and connect with the Indian and Sri Lankan innovation ecosystem.
- The focus was on the showcase and connection of the EU MedTech & Digital Health start-ups and innovative SMEs, with the health technology ecosystem builders - the medical technology users/ adopters - from India & Sri Lanka.
- **81 matchmaking requests sent and 33 B2b meetings were held .**



Biodiversity/Climate Action Programs

GBI engaged and connected with innovation hubs globally to address challenges focused on Biodiversity conservation and climate action. GBI scouted and identified a competitive pool of 80+ global organizations that offered disruptive solutions focused on biodiversity conservation. GBI facilitated multiple B2B and G2G interactions between the various stakeholders.

Lead the Green Change - Biodiversity Means Life Campaign an EU Biodiversity Outreach in India

- To encourage more bilateral collaborations in research, innovation, technology and business, GBI collaborated with the EU Delegation for the '**Biodiversity means Life**' campaign.
- GBI identified and brought together various stakeholders – including citizens, creators, think tanks, academia, innovation hubs, technology companies, private sector, among others – with an interest in nature and biodiversity, and is the foundation of sustainable development and a bilateral, economic, and political topic for dialogue between India and the EU.

The Central Highlands Restoration Project (CHiRP)

- CHiRP was facilitated by GBI, **Commonland**, The Nature Conservancy, and supported by the **IKEA Foundation** to restore the landscape in the region and help local stakeholders to elevate the agroforestry sector and improve their local economy.
- **GBI facilitated multiple stakeholder engagements and showcased technologies and best practices to Village Level Entrepreneurs (VLEs) in the region for tech adoption and deployment.**

Solar Facades for Buildings



Objective:

GBI has been supporting **ZigZag Solar** – a Dutch façade solar solution - to **setup and demonstrate an innovative solution** that harvests solar energy, converts heat into electricity, blocks heat and unwanted radiation from entering the buildings. ZigZag Solar has developed an affordable façade system with integrated solar panels that contributes to the fight against climate change, air pollution, congestion of the electricity grid and the high cost of electricity. As a result, there is a higher value of the building and lower operational cost.

Scope of Work:

- Provided information on the market potential in India.
- Facilitated connects with local vendors to streamline and localize the supply chain.
- Developed a pipeline of projects with architects, project developers, engineering firms, municipalities, building owners especially new constructions and renovations, for residential and commercial buildings.
- Currently we are facilitating the pilot deployment of the solar façade with a large real estate developer in Bangalore, India who are setting up a business park and one of the leading energy universities in India based in Gujarat.
- GBI is also involved with the overall project management, identification of funding, deployment and monitoring of the pilot project.



Real time air quality monitoring & forecasting



Scope of work:

Space Layer Technologies (SLT), a Portugal-based start-up, developed a platform that aggregates environmental data, and by means of machine learning algorithms forecasts air pollution in time and space. They are looking to demonstrate and deploy their platforms in India

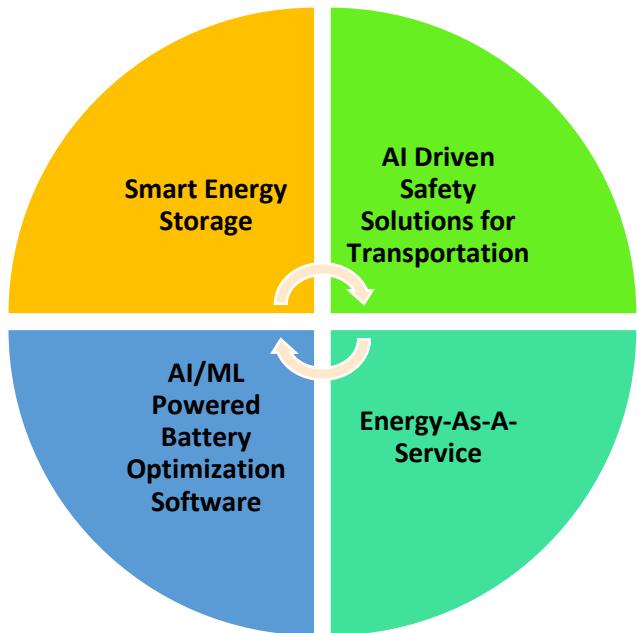

Connecting UK with India: Innovation for Transport and Energy System (ITES)



GBI supported The Energy Systems Catapult (ESC), as partner in India, including the Indian Institute of Science (IISc), on the Innovation for Transport and Energy Systems (ITES) initiative.

Scope of work:

- **40 UK innovators** from the EV and Energy sector were part of the ITES initiative.
- Conducting masterclasses on doing business in India, market opportunities, legal, tax, **IP guidelines**, partner identification, etc.
- GBI supported **2 UK innovators** with pilot projects in India.



UK-India Net-Zero Innovation Program: Connection Manchester Region with Bangalore

GBI supported the Connected Places Catapult (A Innovate UK program) to facilitate the “UK – India Net-Zero innovation Twinning Programme” which focused on supporting UK and Indian innovation districts to find and share novel approaches for addressing net zero challenges through the development of robust and mutually beneficial twinning programme.

The aim of the programme was to create opportunities to establish collaborative relationships between the research and innovation ecosystems in the UK and India, in order to **address net-zero challenges**.

As a part of this programme, a high level delegation from Manchester **visited Bangalore** from the 13th to the 17th of March for a series of interactive **workshops** and site visits to key innovation districts and projects in Bangalore focused on net-zero and sustainability.

Indoor Air Quality Monitoring



Scope of Work:

We are supporting arbnco, UK to pilot and deploy their indoor air quality monitoring system in India under the Innovating for Clean Air (IfCA) programme.

This is a 2-year joint UK-India initiative to provide UK and Indian SMEs with the opportunities to test interventions related to improving air quality and electric vehicle usage in Bengaluru. The programme is funded by Innovate UK

Connecting Wales with India: Promoting Business and Investment into Wales



GBI supported the Welsh government connect with Indian business keen on expanding to Wales/investing in Wales from:

Jaipur region :

- GBI coordinated the visit of representatives of the [Welsh Government](#) to have a workshop and meetings in Jaipur city for two days, with Indian incubators and companies (SMEs, start-ups and corporates) that are keen to expand their business to UK/Europe via Wales, UK. These meetings and workshops allowed Jaipur companies to interact with the Welsh delegates and explore opportunities to invest and expand their business to Europe via the Wales region in Mobility, Automotive and Aerospace Industries, Renewable Energy and Semiconductors sectors.
- Meeting with 10 targeted and Indian companies were set up.

Bangalore region :

- GBI promoted Wales to various startups and SMEs at Bangalore Tech Summit (BTS) 2023 from the Cybersecurity, Med tech, Renewable Energy, Aerospace and Mobility sectors. GBI shared these company contacts with the Welsh government which helped them further set up business meetings in Bangalore with a curated group of 8 Bangalore companies exploring expanding to Wales
- GBI coordinated with Karnataka Government to include Wales in a panel session at BTS and a GBI team member presented the Wales Soft-Landing program designed by the Welsh Government to support India tech businesses to 'soft-land' in Wales.



GBI supported Invest Northern Ireland (NI) to undertake a multisectoral lead generation activity to help identify relevant Indian companies to achieve the FDI objectives.

- GBI created a database of 150 companies from India from Lifescience/Healthcare and ICT, Digital & Creative sectors. GBI did an extensive market research to identify Indian companies who were interested in expanding to Europe/UK via Northern Ireland.
- The database included the company details, contact details of the key CXOs/decision makers, and rationale for selection.



GBI coordinated and organized an Invest NI workshop in Bangalore.

- GBI coordinated the invitations to relevant Indian stakeholders from digital sectors of ICT and healthcare to participate in the workshop.
- GBI also handled all logistical arrangements for the workshop.



US Case Studies

EU – USA Dialogue on Circularity for Cities, May 22nd 2024, Boston



GBI brought together stakeholders in Boston focused on circularity technologies, innovation, projects, business and investment with EU stakeholders and cities and explored how EU-US cities can collaborate through a 2-hour hybrid workshop in Boston, Massachusetts.

Objective of the workshop:

- To launch an EU-US dialogue on Circularity for Cities.
- To bring together stakeholders in Boston from the public and private sector focused on circularity technologies, innovation, projects, business and investment with EU stakeholders and cities
- Explore how EU and US cities can collaborate on the topic of circularity/circular economy
- Best practice exchange between EU-US cities
- Sharing of technologies and technology needs between EU and US cities
- Promoting cities as a living lab to pilot and scale circular technologies and solutions
- Identifying financing and investment opportunities.

The Innovate for Digital India Challenge 2.0

GBI worked with the Department of Science and Technology (DST) on the **Innovate for Digital India Challenge 2.0**, where we supported the top 10 Indian start-ups in an 8-week accelerator program with our partners T-Hub and USMAC.

USMAC Is a high-level tech accelerator that specifically supports non-US start-ups with US market access programs, with a focus on Silicon Valley entries.

Deliverables:

GBI supported the India market access program by facilitating curated one-to-one meetings with potential customers, partners, and investors for the start-ups.

With GBI's support, USMAC planned and, implemented the US market access program, consisting of a 4-day boot camp, virtual mentoring for 4 weeks and a 15 day Soft landing program in Silicon Valley for the selected Indian start-ups.

Bridging Malaysia – India B2B partnerships



Scope of Work:

GBI facilitated a program for a **Malaysian government entity - Malaysian Global Innovation & Creativity Centre (MaGIC)** to support startups to access the Indian market. The Global Market-Fit Programme (GMP) provided a platform for high-growth innovative start-ups to explore cultures, understand ways of business, and gain international market access in countries beyond ASEAN

Deliverables:

- GBI has collaborated with MaGIC to support Malaysian tech startups in the fields of Wastewater treatment, AI, Industry 4.0, EdTech & Food to access the Indian market through collaborations with Indian organizations.

TAITRA & the Center for Green Economy (2017)

Bridging cleantech partnerships between
Taiwan & India



Scope of Work:

GBI aided the Govt. of Taiwan's TAITRA (Taiwan External Trade Development Council) and CGE (Center for Green Economic of Chung-Hua Institution for Economic Research) in scouting for strategic partners to collaborate bilaterally cleantech projects between India and Taiwan.

Deliverables:

Identifying key business opportunities for international trade and projects. Set up meetings with leading Indian cleantech and green policy institutions such as Enzen, CII, Volvo (India), TERI, KUM, and iDECK - which opened up several proposal opportunities.

The GBI team was consequently invited to the "Taiwan Cleantech Business Mission" held in Taipei on 17th-20th of October, 2017, in order to explore more green business opportunities between India and Taiwan. GBI Director, Leena Pishe Thomas delivered a keynote on clean-technology opportunities in India. GBI is currently supporting a Taiwanese energy storage start-up (Gloria Energy Asset Co.) enter the Indian market.
