



Project idea

- Background: Existing Extended Producer Responsibility schemes are underdeveloped or fragmented in the furniture an mattresses, especially for SMEs. There is a pressing need for harmonised, scalable EPR systems that integrate ecodesign, digital tools, and cross-border cooperation to drive sustainable production and waste reduction.
- Concept: The project will design, test, and deploy innovative EPR schemes tailored to the furniture and mattress sectors, integrating ecomodulation, digital tools (e.g. Digital Product Passports), and circular business models. It will engage key stakeholders across the value chain to co-create scalable, cross-border solutions. Emphasis will be placed on practical pilots, data-driven decision-making, and SME support.





Main expertise offered / sought

- We are a business association representing the interests of companies in the furniture and mattress sectors with a direct access to a broad network of industry stakeholders.
- CETEM also acts as a VET centre with a strong track record in Circular economy and ecodesign.
- CETEM coordinates FRANCESCA, funded under HORIZON-CL6-2024-CIRCBIO-01-3, and also participated in FURN360 and ECOSIGN, pioneering educational content and curricula focused on circular practices tailored to furniture and mattress manufacturers.
- Acting as coordinator, CETEM is looking partners active in furniture, mattresses and other (i.e.: carpets) value chains, mainly local authorities, waste management operators and producer responsible organisations (PROs)
