CONTRIBUTION TERMS & CONDITIONS

Contribution Fees and Payment Terms

The contributor acknowledges and agrees that the Contribution Agreement is a binding contract once it is signed by the contributor.

If the Contribution Agreement is concluded, the organizer will invoice the Contributor for the full amount of the Contribution Fee and the payment shall be made in one instalment of 100% of the Contribution Fees.

Cancellation by Sponsor

If the Contributor cancels the Contribution on or before 01. February, 2026 a Cancellation Charge of 50% of the Contribution Fee will apply.

If a Contributor cancels the Contribution after 01. February, 2026, the Contributor agrees to pay 100% of the contracted Contribution Fee as Cancellation Charge. If a Contributor cancels with an outstanding balance due, the Contributor remains responsible for the entire balance due, plus reasonable legal fees to collect.

Cancellations must be received in writing by HTS.

Upon receipt of Contribution cancellation notice, the organizer shall have the absolute discretion to resell the Contribution item(s) forfeited.

The Contributor hereby acknowledges that the cancellation charge represents a reasonable pre-estimate of the likely losses and costs that would be incurred by the organizer as a result of the Contributor's cancellation and that they do not represent a penalty. For the avoidance of doubt, the organizer is not required to mitigate its losses and/or costs in such circumstances and the cancellation charge shall remain payable even where the organizer is able to resell the Contribution item.

If the event can only take place online or not due to force majeure (e.g. pandemic), official orders for which the organizer is not responsible or other reasons for which the organizer is not responsible, or if the implementation has become unreasonable, a cancellation charge of 50% of the Contribution Fee will apply.
