

## Economic Evaluation

### Importance

- Crucial for optimizing resource allocation, ensuring cost-effective treatments, and improving overall healthcare outcomes by assessing the value of interventions relative to their costs

### Actions

- Defining target product profile and target patient population
- Developing value framework and model concept
- Developing and validating health economic models (CEA, BIM, NPV), and adapting them to target countries

### Results

- Supports funding (payer) and market entry (internal) decisions

## Transferability Assessment

### Importance

- Key for assessing the methods, data, results, evidence and implications of various evaluations across jurisdictions in Europe

### Actions

- Definition of country archetypes
- Exploring the relationship between context-specific factors and the parameters of analysis
- Proposing tailored implementation strategies according to country archetypes

### Results

- Supports the implementation of technologies in countries not target of primary research

## Project Sustainability

### Importance

- Secures the ability of a project to maintain its outcomes, impact, and benefits over time, even after the initial funding or support ends

### Actions

- Sustainability Assessment and Planning
- Identification Partners, co-development of Actions
- Extending the scope to Environmental sustainability

### Results

- By securing solid Community, Financial and Organizational foundations, the Project is up and running after Project close

### Importance
