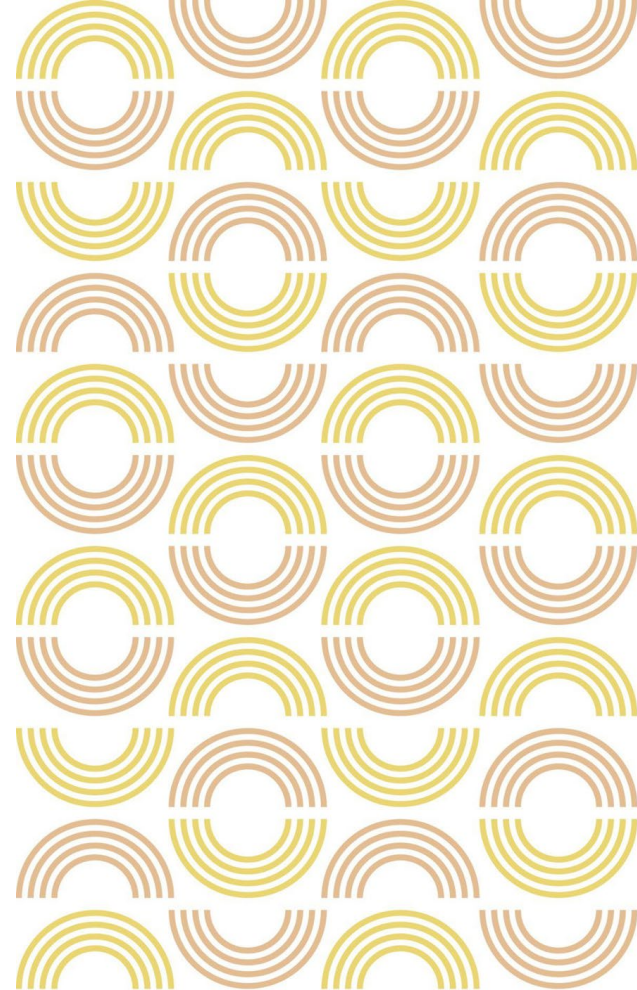

## Project idea

The idea of the project is to create a complete and efficient value chain for hemp production in the EU, contributing to the production of new sustainable products, in order to implement the European Green Deal and to contribute to Europe's sustained competitiveness.
