PROTECTION OF YOUR PERSONAL DATA

This Data Protection Notice (DPN) provides information about the processing and the protection of your personal data.

1. Introduction

The European Commission is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to [Regulation \(EU\) 2018/1725](#) of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

This Data Protection Notice (DPN) explains the reason for the processing of your personal data in the context of *5 years Mission Cancer: Stronger Through Connection*. It explains the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation *5 years Mission Cancer: Stronger Through Connection*, undertaken by the Directorate-General for Research and Innovation (DG RTD) of the European Commission, is presented below.

2. Why and how do we process your personal data?

Purpose of the processing operation: the Controller collects and further processes your personal data to provide you with information about the *5 years Mission Cancer: Stronger Through Connection (before, during and after)* and to process your application for participation in that *5 years Mission Cancer: Stronger Through Connection*.

Live web-streaming and audio-visual recording at the *5 years Mission Cancer: Stronger Through Connection* of the speakers, organisers and participants, as well as photographs of the speakers and panoramic photographs of participants and organisers will be taken and published in the context of the *5 years Mission Cancer: Stronger Through Connection* at [Cancer Mission implementation](#)

The audience or non-speaker participants are not photographed individually or in groups. They may however appear on panoramic photographs of the whole event/audience.

Participants that do not wish to be part of the above web-streaming and recording/publishing activities have the possibility to object to processing, by sitting in back rows which are not recorded/photographed, or if online by turning off their camera to avoid any video recording

Your personal data will not be used for any automated decision-making including profiling.

The data controller shall not be held accountable for any processing of personal data that you might carry out on your own initiative during or after the event. For instance, if you decide to take photographs/audio-visual recordings of participants of the *5 years Mission Cancer: Stronger Through Connection* and/or publish them online, you assume full responsibility for these actions.

3. On what legal ground(s) do we process your personal data?

The processing operations on personal data, linked to the organisation, management, follow-up and promotion of the *5 years Mission Cancer: Stronger Through Connection (including web-streaming, photos, audio-visual recording)* are necessary for the management and functioning of the Commission, as mandated by the Treaties. Those provisions are in particular Article 11 of the Treaty on European Union and Article 15 of the Treaty on the Functioning of the European Union.

Consequently, those processing operations are lawful under Article 5(1)(a) of Regulation (EU) 2018/1725 (*processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body*).

Your consent is required for:

- ☐ The processing of your personal data relating to your dietary requirements and/or access requirements;
- ☐ The sharing of the *5 years Mission Cancer: Stronger Through Connection* participants list containing your name and affiliation with other participants *for the purpose of future collaboration*
- ☐ The sharing of the meeting/event attendee list containing your name and affiliation among participants, in order to create working groups to continue the collaborate work launched during the meeting/event;
- ☐ The processing of your personal data for inviting you to future events the data controller may organise;
- ☐ The processing of your personal data for managing your subscription to a newsletter of the data controller;
- ☐ The processing of your personal data for inviting you to take part to surveys organised by the data controller.

If you opt-in, you are giving us your explicit consent under Article 5(1)(d) of Regulation (EU) 2018/1725 to process your personal data for those specific purposes. You can give your consent via a clear affirmative act by ticking the box(es) on the online registration form.

Your consent for any of these services can be withdrawn at any time, e.g. for unsubscribing from the newsletter by clicking on the 'unsubscribe button' if any, or by sending an email to the contact point of the Controller indicated in Heading 9.

4. Which personal data do we collect and further process?

The following personal data will be processed:

- Identity (*function/title, first name, last name, name of organisation, city, country*);
- Contact details (*e-mail address, telephone number*);
- Nationality, passport or identity card number and its date of issue and expiry date may be collected, so that the data subjects may obtain access to the premises where the meeting/event is held;
- Dietary requests or specific access requirements.

5. How long do we keep your personal data?

The Data Controller only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing.

For each of the categories of personal data that is processed, please find below the retention details and the reference to the relevant record of processing:

- ☐ All personal data related to the organisation and management of the *5 years Mission Cancer: Stronger Through Connection* (*this includes the information given during the registration, before, during or after the event*) will be deleted **one year** after the last action in relation to the *5 years Mission Cancer: Stronger Through Connection*;
- ☐ Sensitive personal data relating to dietary and/or access requirements will be deleted as soon as they are no longer necessary for the purpose for which they have been collected in the framework of the *5 years Mission Cancer: Stronger Through Connection*, but no later than within **1 month** after the end of the *5 years Mission Cancer: Stronger Through Connection*;
- ☐ Recordings from the web-streamed *5 years Mission Cancer: Stronger Through Connection* will be kept for **2 years** before being deleted. More information is available in the Record of Processing [DPR-EC-00306](#) (*Web-streaming of Commission events*);

- In case of audio-visual recording of the *5 years Mission Cancer: Stronger Through Connection*, the recordings will be kept for **5 years** after the *5 years Mission Cancer: Stronger Through Connection* before being deleted. More information is available in the Record of Processing [DPR-EC-01937](#) (*Audio-visual recording of meetings*);
- Personal data shared with the controller for future mailing purposes (*e.g. for receiving newsletters or invitations to similar events*) are processed in line with the Record of Processing [DPR-EC-03928](#) (*Management of subscriptions to receive information*) and the *specific privacy statement prepared by the organising Commission service*);
- Selected service providers for organisational purposes (*such as caterers, travel agents or event management organisations*) are contractually bound to process personal data on behalf of and in line with the instructions of the data controller, keep confidential any data they process and protect it from unauthorised access, use and retention.

6. How do we protect and safeguard your personal data?

All personal data in electronic format (*e-mails, documents, databases, uploaded batches of data, etc.*) are stored on the servers of the European Commission (*and of its contractors if contractors are engaged to assist the controller in the organisation and management of this meeting/event*) .

All processing operations are carried out pursuant to [Commission Decision \(EU, Euratom\) 2017/46](#) of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of given processing operations.

The Commission's contractors are bound by specific contractual clauses for any processing operations of your personal data on behalf of the Commission, and by the confidentiality obligations deriving from the General Data Protection Regulation ('GDPR' - [Regulation \(EU\) 2016/679](#)).

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to other authorised Commission staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

Where necessary, we may also share your information with service providers for the purposes of organising the *5 years Mission Cancer: Stronger Through Connection*:

- *ICF NEXT S.A.*, 17 Avenue Marnix, 1000 Brussels, Belgium, the Commission's contractor acting as data processor organising the event, and subcontractors:
- *IP Travel* - For the purpose of booking travel arrangements. IP Travel will process the following personal data: full name, mobile phone number, nationality, date of birth, gender, country, outgoing and incoming city, email address, passport number and expiration date. - *Pullman Hotel* - for the purpose of booking accommodation, we will share relevant reservation details (e.g., name). Be aware that the hotel will further process your personal data outside of the control of the European Commission, as data controllers in their own right and subject to their own privacy policy. - *Onetec Badging* - for the purpose of receiving your event badge, we will share relevant information (full name, email, company and category of registration) (for badging system - <https://wp.onetec.eu/privacy-policy/>)

Third party IT tools, including Social Media

We use third party IT tools to:

- Manage event registration, and event interactions, through the B2match platform. The personal data you provide during your registration, will be processed by B2Match on behalf of the event organiser for these purposes. B2Match are based in Austria, and use Cloud Services from Google. According to its terms, B2Match may use aggregated and anonymous information for service analytics, benchmarking purposes, further information is available in B2Match [Privacy Policy](#) and terms of use.
- inform about and promote the *5 years Mission Cancer: Stronger Through Connection* through widely used communication channels, including the social media. For detailed information about the use of social media by the European Commission, see the Record of Processing [DPR-EC-00073](#) (Social Media Use by the European Commission).

In order to protect your privacy, our use of third party IT tools to connect to those services does not set cookies when our website pages are loaded on your computer (or other devices), nor are you immediately redirected to those social media or other websites. Only in the event that you click on a button or “play” on a video to watch it, a cookie of the social media company concerned will be installed on your device. If you do not click on any social media buttons or videos, no cookies will be installed on your device by third parties.

In order to view such third-party content on our websites, a message will alert you that you need to accept those third parties’ specific Terms and Conditions, including their cookie policies, over which the Commission has no control.

We recommend that users read the relevant privacy policies of the social media tools used. These explain each company’s policy of personal data collection and further processing, their use of data, users' rights and the ways in which users can protect their privacy when using those services.

The use of a third party IT tool does not in any way imply that the European Commission endorses them or their privacy policies. In the event that one or more third party IT tools are occasionally unavailable, we accept no responsibility for lack of service due to their downtime.

Please note that pursuant to Article 3(13) of Regulation (EU) 2018/1725 public authorities (*e.g. Court of Auditors, EU Court of Justice*) which may receive personal data in the framework of a particular inquiry in accordance with Union or Member State law shall not be regarded as recipients. The further processing of those data by those public authorities shall be in compliance with the applicable data protection rules according to the purposes of the processing.

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

8. What are your rights and how can you exercise them?

You have specific rights as a ‘data subject’ under Chapter III (*Articles 14-25*) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) of Regulation (EU) 2018/1725 on grounds relating to your particular situation.

The data will ensure that the data subjects can exercise their right to object to processing whenever possible by the organisers of the meeting/event (*for example, on the spot by indicating a non-web streamed seat if requested; or ex-post, by deleting a specific sequence from the online video/voice recording*).

You have consented to provide your personal data to the data controller for the present processing operations. You can withdraw your consent at any time by notifying the data controller. The withdrawal of your consent will not affect the lawfulness of the processing carried out before you have withdrawn the consent.

You can exercise your rights by contacting the data controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor.
